Dear Ms Walli:

In accordance with the Decision and Order dated April 14, 2011, Westario Power Inc. (WPI) has reviewed the draft Tariff of Rates and Charges and would like to bring to the attention of Board staff an error in the Excel file Westario_STS_FINAL, in particular tab B1.1 Re-Based Bill Det & Rates. The volumetric rate inputted for General Service less than 50kW should be \$0.0091, not \$0.0910. The rates are provided from the Excel file Westario_RG_Final, tab E1.1 Rate Reb Base Dist Rts Gen and is reproduced below:

WPI requests Board staff to update the Excel file Westario_STS_FINAL to correct this error and provide a revised Tariff of Rates and Charges sheet. WPI has no additional concerns to report.
