- **for the designation of two proposed natural gas storage pools, the Bayfield Pool and the Stanley 4-7-XI Pool in the geographic township of Stanley, Municipality of Bluewater, County of Huron by Tribute Resources Inc. And Bayfield Resources Inc., on behalf of the Huron Bayfield Limited partnership**
- **for the authority to inject gas into, store gas in and remove gas from designated storage areas**
- **for the licences to drill wells in designated storage areas**
- **for a determination in respect of compensations payable under Section 38 of the Ontario Energy Board Act, 1998**
- **for leave to construct a natural gas transmission pipeline in the County of Huron and in the County of Middlesex by Bayfield Pipeline Corporation Leave to construct a natural gas transmission pipeline in the County of Huron and in the County of Middlesex by Bayfield Pipeline Corp.**

The Zurich Landowners Association has been established to deal with the planned Zurich Pool gas storage project initiated by Tribute Resources Inc. We represent the majority of over 130 landowners offered lease contracts by Tribute Resources Inc. and in opposition to the storage of gas below the Village of Zurich.

We expect Tribute Resources to move forward with this undertaking following the Ontario Energy Board's decisions on the above mentioned applications. The Zurich Pool gas storage project, if approved, would become an extension the current Bayfield/Stanley Pool projects, sharing the Bayfield/Stanley pipeline as it is now proposed in the above mentioned applications. Tribute's intention to move forward with the Zurich pool development was confirmed in an email to us from Mr. Bill Blake, then Vice President of Operations for Tribute Resources Inc., December 9, 2009.

The Zurich Landowners Association has a direct interest in the above mentioned applications and direct involvement in the proposed pipeline application and submits this request for intervenor status in the noted proceedings.

The Zurich Landowners Association does not have a preference with respect to an oral or written hearing. The Zurich Landowners does ask to reserve the right to seek costs subject to the extent of our involvement. The Zurich Landowners Association reserves its right to participate in all aspects of the noted proceeding, including evidence, interrogatories, cross-examination and argument.
