The Board has reviewed your application for an electricity wholesaler licence. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Licence application fee: You have submitted a licence application fee in the amount of \$200. Application fee of \$200 applies only when the applicant has paid an annual registration fee for the year in which a licence application is filed prior to filing a renewal application, i.e. 2011-12 application fee had to be paid. Please note, if the licence is issued, Williams Operating Corporation will not be invoiced for 2011-12 annual registration fee. Please submit additional \$800 for the licence application fee.
2. Section 8. Corporate Organization requires the applicant to describe its corporate organization structure. No explanation has been provided in this section. However, according to the applicant's financial statements, the applicant has a Parent company. Please describe the applicant's corporate organization structure.
3. Section 10. Technical Resources: According to the answer provided, Williams Operating Corporation does not employ any personnel with technical qualifications and experience in wholesaling electricity, nor does the applicant have plans to acquire technical resources for technical matters related to electricity wholesaling activities. Please describe how the applicant plans to participate in the wholesale electricity market in Ontario without adequate technical resources.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
