- a) Please confirm the status of Welland Hydro's smart meter deployment and TOU implementation as of May 1, 2011.

Response:

The remaining installations are all three phase smart meters for which delivery from the supplier has been delayed. The first of these meters were received in May, 2011 and installation has begun. The remaining meters are expected to be received and installed by the end of October, 2011.

Welland Hydro has been mandated to begin TOU pricing in September, 2011 but has requested a four month extension to January, 2012.

- b) Please specify and describe in detail the extraordinary and unanticipated circumstances that have led Welland Hydro to request an extension to its mandated TOU pricing date.

Response:

Welland Hydro filed its initial MDM/R testing and enrollment schedule based on making revisions to an existing billing system. This system was custom built and is unique to Welland Hydro and would require extensive changes to integrate into the complex MDM/R environment. This would require significant time, testing, and costs yet still leave a core billing system which had been in place for approximately thirteen years. In addition, sourcing the necessary resources to program any changes to the existing system has been challenging. As a result, as indicated in its response to the OEB in July, 2010 Welland Hydro determined that a more strategic decision would be to purchase a Harris North Star CIS system which was already in place at over forty LDCs in Ontario. This software was purchased with MDM/R and Time of Use functionality and would integrate into the software selected for Welland Hydro's ODS which is Harris Meter Sense. All of the above issues along with the announced retirement of the Director of Information Services who has kept the existing billing system operational contributed to the decision to purchase a new CIS.

An integral part of the strategy to implement the new billing system was to do it as part of Utility Collaborative Services (UCS) which is a co-operative of ten small to mid size LDCs. This would provide Welland Hydro with access to software at group pricing and cost sharing in any further modifications required. It also provided Welland Hydro access to a very extensive knowledge base of the CIS System and the MDM/R testing process. This shared specialized knowledge base is also cost efficient versus hiring additional personnel in house.

Welland Hydro had indicated in July, 2010 to the Board that an expected completion date for the new CIS was in March 2011. This target date was kept with the new system in place to bill customers as of February 28, 2011. Upon successful conversion, Welland Hydro and USC reviewed the MDM/R plan and had first thought that testing could begin in April, 2011. The new Billing & MDM/R Supervisor would be the lead in the TOU project. However, start up conversion issues and the training of a new billing clerk would not allow testing to begin as scheduled. After consulting the IESO on the current schedule for Welland Hydro, it was their recommendation that any new billing system should be in place for at least four months before beginning MDM/R testing. As a result, Welland Hydro submitted a request for a four month extension to the Board on April 19, 2011.

- c) Please provide the timelines for Welland Hydro's revised MDM/R testing and enrollment schedule.

Response:

The attached spreadsheet (Appendix A) details Welland Hydro's revised MDM/R testing program. This document has been reviewed with and accepted by the IESO in May, 2011.

- d) Please provide the details of and rationale for Welland Hydro's proposed TOU Billing implementation schedule, including:
- i) billing cycle dates
 - ii) number of customers on each billing date

Response:

The following is the June schedule for billing potential TOU customers for both Residential and GS<50 classes. Dates and number of customers in each class will be similar when Welland Hydro transitions to actual TOU billing in February, 2012 for January 2012 consumption.

Welland Hydro is currently receiving residential smart meter readings for billings through the AMI (Sensus). As a result, the above billing cycles will be very similar when cutting over to time of use. General Service less than 50kW are still read manually until the AMI can read kW. The monthly billing cycle for these customers may change slightly once all systems are fully operational.

The timelines for the MDM/R and TOU implementation schedule have been based on the extensive experience of other members within UCS. Many of these members are currently in the process of moving or have moved into the live production system of the MDM/R.

Welland Hydro can report to the Board that unit testing within the MDM/R Sandbox started in late May, 2011 which is in line with the revised plan submitted to the IESO. This testing will be performed by Welland Hydro personnel with the assistance of staff from UCS with significant MDM/R testing experience.

- e) Are there any other factors (internal and/or external) that Welland Hydro has identified that may hinder its ability to comply with their requested mandatory TOU date?

Response:

Welland Hydro believes that it has the internal and external resources available to meet the requested TOU date of January, 2012 for billing in February, 2012. Welland Hydro will be working closely with our external partners UCS, Harris, ITM and Sensus to identify issues as they arise which may impact the target date and find solutions to avoid any further delays.

- f) Is there a possibility that Welland Hydro can gain efficiencies during TOU Implementation and complete TOU rollout prior to the requested extension date? If so, what date does Welland Hydro expect it could complete TOU rollout by?

Response:

Given the experience gained by UCS at other LDCs Welland Hydro is confident that the extension date will be met. If possible, Welland Hydro will cut over to TOU pricing at the earliest possible date. Welland Hydro would not expect this to be any earlier than December, 2011 with billing for January, 2012.
