I am writing to request the assistance of the Board in respect of Procedural Order No. 1, as well as clarification concerning obtaining more responsive/detailed answers to Interrogatories which NAN directed to Remotes.

Issue #1: Unresponsive or unclear responses to certain Interrogatories

NAN has carefully reviewed Remotes' answers to NAN's Interrogatorics. NAN has concluded that certain responses are unclear or lacking in sufficient detail, while other answers are actually unresponsive to NAN's Interrogatories.

NAN is aware that a motion can be brought before the Board for an appropriate order to deal with inadequate responses to Interrogatories.

However, given that this proceeding does not involve an oral hearing, NAN would like to see if its concerns can be resolved in a more informal way, which would reduce the costs of the parties to the proceeding.

Accordingly, NAN is proposing that it have direct contact with Remotes to try to work out an agreement relating to the information which NAN submits is lacking and which NAN believes Remotes should be producing to properly answer certain Interrogatories.

Issue #2: Timelines in Procedural Order No. 1 (dated 21 April 2011)

NAN is aware of the deadlines identified in Procedural Order No. 1. Given the issues relating to the adequacy of Remotes' answers to certain Interrogatories, as outlined above, NAN will not be in a position to deliver its submissions by the June 9, 2011 deadline under Procedural Order No. 1.

In addition, NAN requires additional time to obtain information from certain Band Council members in select NAN communities to prepare its evidence and submissions for the OEB.

Toward this end, NAN is requesting that the June 9, 2011 and June 23, 2001 deadlines in the said Order be vacated, with alternative deadline dates being set as soon as NAN and Remotes have had a chance to deal with the responses to certain Interrogatorics and NAN has had an opportunity to make additional inquiries with Band Council members in certain communities served by Remotes.

NAN believes that, with the co-operation and assistance of Remotes, NAN's disclosure issues and its own logistical issues (relating to contact with certain Bank Council members) could be resolved quickly, such that the timetable in Procedural Order No. 1 would only be delayed by a few weeks.

I look forward to hearing from the Board and Remotes in respect of the issues raised herein. Thank you.
