Pursuant to Procedural Order No. 1, dated January 24, 2008, Energy Probe Research Foundation (Energy Probe) is hereby providing written submissions for the Board's consideration in respect of the Draft Issues List. An electronic version of this communication will be forwarded in PDF format.
