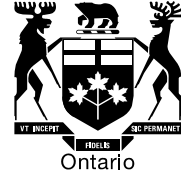

Re: Summerhaven Wind, LP Leave to Construct Application (EB-2011-0027)

The Ontario Energy Board ("Board") has received your letter dated June 10, 2011 in which you request that the Board clarify the scope of the Board's Procedural Order No. 6 in the subject matter.

In particular, you ask whether it is reasonable for the IESO to file interrogatories on additional information that was provided by Hydro One Networks Inc. ("Hydro One") during the course of the Technical Conference held on May 17th, 2011, the transcripts of which now form part of the evidentiary record in the proceeding. You indicate that the IESO believes certain information that was revealed by Hydro One in the course of the Technical Conference is relevant and important to a rational outcome in this proceeding and you suggest that the IESO's interrogatories could be filed in accordance with Part 2 of Procedural Order No. 6 in this proceeding.

Though the original intention of Part 2 of Procedural Order No. 6 was to allow for questions related to the evidence filed by Haldimand County Hydro Inc., the Procedural Order is drafted in a general way and your interpretation is reasonable. The Board is interested in having as complete a record as possible in this proceeding and will therefore allow the IESO to file interrogatories on the evidence provided by Hydro One at the Technical Conference.

The Board notes that the timelines in Procedural Order No. 6 required written interrogatories be filed no later than Wednesday June 8th, 2011 and responses to those interrogatories be filed no later than June 15th, 2011. Given that the first of these dates has passed, that Hydro One should be provided with sufficient time to respond and that

the Board does not wish to alter the dates for submissions in this matter, the Board will therefore provide for the following:

1. The IESO shall file its interrogatories directed to Hydro One **no later than Tuesday June 14th, 2011**; and
2. Hydro One shall respond to any such interrogatories filed by the IESO **no later than Tuesday June 21st, 2011**.
