## NOTICE OF APPLICATION AND WRITTEN HEARING

### **Application by Kitchener-Wilmot Hydro Inc. for an Extension to its Mandated Time-of-Use Pricing Date for Certain Regulated Price Plan Consumers**

#### **The Application**

Kitchener-Wilmot Hydro Inc. ("Kitchener-Wilmot") filed an application dated June 14, 2011 with the Ontario Energy Board under section 74 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B) for a licence amendment granting an extension in relation to the mandated date for the implementation of time-of-use ("TOU") pricing rates for certain Regulated Price Plan ("RPP") consumers.

#### **Time-of-Use Pricing**

On August 4, 2010 the Ontario Energy Board issued a determination under Section 1.2.1 of the Standard Supply Service Code to require the implementation of TOU pricing for RPP consumers. The determination established mandatory TOU implementation dates for each electricity distributor. Kitchener-Wilmot has applied for an extension to its June 2011 TOU pricing date and requested a new date of January 31, 2012 for approximately 7,500 General Service <50kW customers. Kitchener-Wilmot states the extension is necessary due to an issue with certain three phase meters for these customers that are delivering suspect interval data due to improper time-alignment of the consumption intervals.

### **How to Participate in the Hearing**

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for not holding a written hearing. If you object to a written hearing for this application, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by **July 14, 2011**.

Any parties who wish information and material from the applicant that is in addition to the applicant's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before **July 18, 2011**. Where possible, the questions should specifically reference the pre-filed evidence. The applicant shall file with the Board complete responses to the interrogatories and deliver them to any interested parties in the proceeding no later than **July 25, 2011**.

Anyone who wishes to make a submission on the application must file that written submission with the Board and deliver it to the applicant by **August 2, 2011**. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by **August 9, 2011**. All written submissions sent to the Board will be placed on the public record. The written submissions will be available for viewing at the Board's offices and will be placed on the Board's website.

If the written submission is from a private citizen (i.e., not a lawyer representing a client, not a consultant representing a client or organization, not an individual in an organization that represents the interests of consumers or other groups, and not an individual from a regulated entity), before placing the written submission on the public record, the Board will remove any personal (i.e., not business) contact information from the written submission (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.

### **How to File Documents with the Board**

You must forward two paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission to the Board and one copy to the applicant. All submissions must quote file number EB-2011-0239 and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
