You are directed to:

All Aboriginal groups with any interest in the lands affected by the subject project, including Cladwell First Nation, Bkejwanong Territory, Aamjiwnaang First Nation, Chippewas of the Thames First Nation, Chippewas of Kettle & Stoney Point, Oneida Nation of the Thames, Six Nations of the Grand River -Six Nations (Part) 40, Six Nations of the Grand River - Haudenosaunee Confederacy Council, Wahta Mohawks, Mohawks of the Bay of Quinte -Tyendinaga Mohawks, Mohawks of Akwesasne, Delaware Nation (Moravian of the Thames and Munsee-Delaware Nation).
