NOTICE OF APPLICATION

ENBRIDGE GAS DISTRIBUTION INC.

ORDER OR ORDERS APPROVING THE BALANCES AND CLEARANCE OF CERTAIN DEMAND SIDE MANAGEMENT VARIANCE ACCOUNTS INTO RATES, AS AT APRIL 1, 2008

Enbridge Gas Distribution Inc. ("EGD") has filed an application with the Ontario Energy Board, (the "Board") dated December 7, 2007, under section 36 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B for an order or orders approving the final balances and clearance of certain Demand Side Management ("DSM") variance accounts into rates, as at April 1, 2008. These variance accounts include: the 2005 Lost Revenue Adjustment Mechanism ("LRAM") variance account; the 2005 DSM variance account; the 2005 Shared Savings Mechanism ("SSM") variance account; the 2006 LRAM variance account, the 2006 DSM variance account and the 2006 SSM variance account (the "Accounts"). The total amount sought to be recovered is \$11,129,564, and the estimated impact on a typical Rate 1 and Rate 6 customer is 0.2% of the annual bill.

The Board has assigned File No. EB-2007-0893 to this application.

EGD has also applied to the Board for such final and interim orders and/or accounting orders as may be necessary in relation to clearance of the Accounts which are the subject of this Application.

Copies of the application and the pre-filed evidence in support of the application will be available for public inspection at the Board's offices and at Enbridge Gas Distribution Inc.'s head office.

How to Participate

You may participate in this proceeding in one of three ways:

You may send the Board a letter of comment. Your letter must be received by the Board no later than **20 days** from the receipt of this notice.

You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than **10 days** from the receipt of this notice.

You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than **10 days** from the receipt of this notice, or, if you have been served this notice personally, no later than **10 days** from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board intends to hold a written hearing in this case. If you feel an oral hearing is appropriate, your letter of intervention should explain why the Board should consider an oral hearing. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
