2. If PowerStream Inc. is a Host Distributor, to immediately, and no later than the

date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);

3. To serve a copy of the Notice and the application directly to the intervenors of record in the proceeding held to approve smart meter cost recovery in PowerStream Inc's South rate zone (EB-2010-0209);
4. To file with the Board, both electronically and hard copy, an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
5. To make a copy of the application and evidence, and any amendments thereto, available for public review at PowerStream Inc.'s office and on its website; and,
6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
