AND IN THE MATTER OF an application pursuant to section 86(1)(b) of the *Ontario Energy Board Act, 1998* by Hydro One Networks Inc. seeking an order granting Hydro One Networks Inc. leave to sell distribution assets to Kilsyth Country Campground.

DECISION AND ORDER

On May 12, 2011, Hydro One Networks Inc. ("Hydro One") filed an application with the Ontario Energy Board under section 86(1)(b) of the *Ontario Energy Board Act, 1998* for an order granting Hydro One leave to sell distribution assets to Kilsyth Country Campground.

The Board assigned file number EB-2011-0142 to the application. The assets being sold consist of two overhead distribution transformers at the service location.

Hydro One requested, with Kilsyth Country Campground's consent, that the Board dispose of this matter without a hearing under section 21(4)(b) of the Act. I find, based on the evidence filed in the application, that no person will be adversely affected in a material way by the outcome of this proceeding. I have therefore disposed of this matter without a hearing.

Findings

Section 86(1)(b) of the Act provides that leave of the Board is required before a distributor can “sell, lease or otherwise dispose of that part of its transmission or distribution system that is necessary in serving the public.” The assets that are the subject of this transaction are necessary in serving the public.

Hydro One stated that the assets proposed for sale currently serve and will continue to serve Kilsyth Country Campground. After the sale, the assets will be owned by Kilsyth Country Campground but Hydro One will continue to be the supply utility.

Hydro One also stated that the transaction will not affect the safety, reliability, quality of service, operational flexibility or economic efficiency of Hydro One or Kilsyth Country Campground.

The total sale price of \$8,502.76 plus HST covers the net book value of the assets. Hydro One further stated that there will be no material impact on its ratepayers or any other parties as a result of this transaction.

I find that it is in the public interest to grant Hydro One leave to sell the assets described above to Kilsyth Country Campground.

IT IS ORDERED THAT:

Hydro One Networks Inc. is granted leave to sell to Kilsyth Country Campground, the assets generally described in the application as two overhead distribution transformers (one 25 kVA transformer (2006) and one 50 kVA transformer (2007)) at the service location of 101739 Grey Road 5, Lot 10, Concession 7 in the Township of Georgian Bluffs, Ontario.
