LETTER OF INTERVENTION

I must object to granting Hydro One Networks Inc. ("Hydro One") a six (6) months of extension of the timelines for the connection of micro embedded generators. They have been given ample time to resolve their outstanding issues. Hydro One has not complied with the law in my application process. The details are as follows:

1. My project was completed and inspected by the ESA on October 29, 2010;
2. On November 12, 2010, I submitted my completed application requesting connection to Hydro One;
3. On January 28, 2011, I was advised that my application was under review;
4. On February 11, 2011, I was advised that Hydro One would not provide me with an Offer to Connect;
5. On June 23, 2011, I was advised that system upgrades were in the process of being completed and that I should receive an Offer to Connect on or before August 2011;

Given the foregoing, it is clear that the timelines required by law have not been met by Hydro One. I have invested considerable monies in reliance on Hydro One's obligation to comply with the same. The failure to comply to date and the prospect of further exemption from compliance, only increases the financial losses being suffered by me. Should Hydro One provide me with an Offer to Connect on or before August 31, 2011, then my losses will end and my personal objection to Hydro One's application will be withdrawn. However, until this occurs, I object to any application to further extend the time required by law.
