We have submitted a previous letter of concern to the Ontario Energy Board and the Applicant, South Kent Wind LP. This document is intended as a follow up letter clarifying our concerns in light of additional information.

**Regarding the interests of consumers with respect to price, reliability and quality of electrical service we would like to voice our concerns:**

- It is unclear to us that this land use is legal, as it is not for the purpose of the railway.
- We have learned from Jim Hogan (C-K Energy) that C-K Energy has obtained an easement from the current owners, CN, to construct a "utility power corridor". It is unclear from the current information whether this change of land use is allowed by the current zoning. Additionally, it is unclear what restrictions will be in place to guarantee that additional lines carrying additional power will not be installed without consultation of residential constituents regarding issues of safety and any resulting liability from the proposed or additional power lines.
- It is unclear to us who, under the current agreements, will take on the liability with respect to required upkeep, drainage, pest and noxious weed control which affect surrounding farmland. Additional liability concerns would include signage and enforcement of trespassing, littering and hunting violations.

**Regarding the interests of price and reliable promotion of renewable energy:**

- We are concerned that the use of this land, if it had been offered to local farmers or to be used in conjunction with local farmers and the applicants, could be put towards effective farming and increased efficiency of current agricultural operations including crops for biofuels and renewable energy.

As mentioned previously we have applied for our intervenor ID# and we look forward to your response to our concerns.
