Re: Application to amend electricity generation license EG-2008-0095 (the "Licence")

On behalf of Solaris Energy Partners Inc. ("**Solaris**") and pursuant to s.57(c) of the *Ontario Energy Board Act*, 1998, S.O.c. 15, Sched. B. (the "**OEB Act**"), we hereby submit a request to amend the Licence, which was issued to Solaris by the Board in a decision and order dated July 11, 2008.

Solaris is seeking Board approval to amend (the "Requested Amendment") Schedule 1 of the Licence to amend the reference to "Stardale Solar Park #1" and the address thereof to read as follows:

"Stardale Solar Park #1 & 2, owned and operated by the Licensee on the lands legally described as PIN 54191-0186 (LT) being Part of Lot 23 and Part of the northerly half of Lot 24, Concession 5, designated as Part 1 on Plan 46R-7233, Township of East Hawkesbury, in respect of the 10 megawatt solar project relating to RESOP Contract 13420 and in respect of the 10 megawatt solar project relating to RESOP Contract 13372; and

Please note that I had previously sent you a letter on June 17, 2011 seeking to amend Schedule 1 of the Licence, a copy of which is attached hereto as Exhibit A. Following consultations with Solaris' real property consultants, it has been determined that the above-noted description is the preferred description for the licensed generation facilities and accordingly <u>I ask you to disregard my letter of June 17, 2011</u>.
