NOTICE OF INTERVENTION

OF THE

VULNERABLE ENERGY CONSUMERS COALITION

- 1. The Vulnerable Energy Consumers Coalition (VECC) hereby expresses its intention to intervene and participate in the above-mentioned proceeding. VECC consists of the following organizations:
 - (a) The Federation of Metro Tenants Association (FTMA)
 - (b) The Ontario Coalition of Senior Citizens' Organizations (OCSCO)

2. The Federation of the Metro Tenants Association (the "FTMA") is a non-profit corporation composed of over ninety-two affiliated tenants associations, individual tenants, housing organizations, and members of non-profit housing co-oops. In addition to encouraging the organization of tenants and the promotion of decent and affordable housing, the Federation provides general information, advice, and assistance to tenants. 3. The Ontario Coalition of Senior Citizens' Organizations ("OCSCO") is a coalition of over 160 senior groups as well as individual members across Ontario. OCSCO represents the concerns of over 500,000 senior citizens through its group and individual members. OCSCO's mission is to improve the quality of life for Ontario's seniors. OCSCO's address is:

- 4. The coalition of the FMTA and OCSCO under the name VECC has the specific mandate of intervening in proceedings to advocate on behalf of the interests of Ontario's vulnerable consumers with respect to energy issues, primarily through intervention in regulatory proceedings at the Ontario Energy Board.
- 5. Although the organization is not itself a member of VECC, the Public Interest Advocacy Centre (PIAC) in Ottawa assists in the representation of

the interests of vulnerable consumers by ensuring the availability of competent representation and consultant support to the VECC participation.

- 8. VECC requests that a paper copy of the application and any additional supporting materials be forwarded to Mr. Garner at the above address and that electronic copies be sent to both Mr. Buonaguro and Mr. Garner at their respective e-mail addresses.
- 9. In addition to the usual issues related to a cost of service application, VECC notes that Guelph Hydro Electric Systems Inc. (Guelph Hydro) has filed evidence on a number of other issues including: changing its fiscal

year; recovery of LRAM and SSM amounts; recovery of stranded meter costs; and an asset management plan. VECC also made submissions in Guelph Hydro's most recent IRM application EB-2010-0130 in respect to an incremental capital funding request. In the related decision the Board ordered Guelph Hydro to make certain reports related to capital expenditures. The Board's disposition of these and other issues in the application may affect consumers represented by VECC.

- VECC notes that it has previously been approved as an intervenor in proceedings related to Guelph Hydro, including its last distribution rate application EB-2010-0130 and its last cost of service rebasing application EB-2007-0742. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of electricity are fully represented in the determination of just and reasonable rates for 2012 and, insofar as the new rates requested in this application will form the basis for a future IRM regime, the years beyond 2012.
- 11. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
- 12. VECC's members do not have access to the direct funding required to retain appropriate legal and consulting support for its intervention in OEB

proceedings. Accordingly VECC relies on PIAC to provide legal support and retain qualified consultants on the basis that PIAC can recover the related fees and disbursements from the Board based on the Board's Practice Direction on Cost Awards at the prevailing Cost Award Tariff.
