**Re: EB-2011-0260: TransCanada Power Transmission (Ontario) L.P. Application
for a Licence Amendment**

Request for Intervenor Status

We are counsel to Upper Canada Transmission Inc. (UCT) in its Application for an Ontario Transmission Licence (EB-2011-0222). We write in respect of the Board's letter to counsel for TransCanada Power Transmission regarding TransCanada Power's application to the Board for amendment of TransCanada Power's recently granted Transmission licence. We have also reviewed the July 8th letter from counsel for TransCanada Power to the Board which initiated TransCanada Power's amendment application.

Issues have arisen in UCT's currently pending Application regarding applicability of the Board's *Affiliate Relationships Code for Electricity Distributors and Transmitters* to newly licenced transmitters prior to the ownership by those licensees of assets or the application by those licensees for transmission development designation. Accordingly, UCT has an interest in the outcome of TransCanada Power's amendment application.

UCT anticipates that the Board will initiate a written hearing process in TransCanada Power's application. UCT hereby requests intervenor status in that application, and would like to receive copies of further correspondence related thereto. UCT does not intend to seek an award of costs for its intervention.
