## PROCEDURAL ORDER NO. 12

The Ontario Energy Board (the "Board") received a Notice of Motion from the Consumers Council of Canada and Aubrey LeBlanc ("CCC") regarding the assessments issued by the Board pursuant to section 26.1 of the *Ontario Energy Board Act*, 1998 (the "Act") (the "Constitutional Motion").

On May 11, 2010, the Board issued a Notice of Hearing and Procedural Order No. 1.

The following parties requested and were granted intervenor status in this proceeding: Canadian Manufacturers & Exporters; the Industrial Gas Users Association; Toronto Hydro Electric System Limited; Vulnerable Energy Consumers Coalition, Enbridge Gas Distribution Inc.; Union Gas Limited; and the Association of Power Producers of Ontario.

The Board has issued a number of Decisions and Orders during the course of this proceeding. Anyone who wishes information on what has transpired to date should refer to those Decisions and Orders.

The Board considers it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

## THE BOARD THEREFORE ORDERS THAT:

- 1. CCC, and any intervenors that support the relief sought by CCC, shall file their written final argument with the Board and serve it on all intervenors and the Attorney General of Ontario on or before **September 6, 2011.**
- 2. The Attorney General of Ontario, and any intervenor opposed to the relief sought by CCC, shall file their written final argument with the Board and serve it on all other intervenors on or before **September 19, 2011.**
- 3. If Board staff wishes to file a written submission in relation to the relief sought by CCC, Board staff shall file its written final submission with the Board and serve it on CCC, the Attorney General of Ontario and all other intervenors on or before **September 26, 2011.**
- 4. An oral hearing to hear final argument will commence in the Board's hearing room on **October 6, 2011** at 2300 Yonge Street, 25th Floor, Toronto, at 9:30 am.

All filings to the Board must quote file number EB-2010-0184, be made through the Board's web portal at www.errr.ontarioenergyboard.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="https://www.ontarioenergyboard.ca">www.ontarioenergyboard.ca</a>. If the web portal is not available you may email your document to the address below.
