The Board has reviewed your application for an electricity retailer licence. Your application is currently incomplete and cannot be processed until the following has been filed:

- 1. Question 14 (g), pages 12 and 13: With respect to the complaints identified for each quarter from Q3 in 2009 to Q2 in 2011, please provide concise details by quarter the type of customer complaints and how by introducing new customer contracts will reduce complaints in the future.
- 2. Question 14 (h), pages 14 and 15: Your response refers to the Ontario Energy Board rather than regulatory bodies other than the Ontario Energy Board. Please review the question again and respond accordingly.
