

**Re: Application for Electricity Wholesaler Licence
Board File Number EB-2011-0265**

The Board has reviewed your application for an electricity wholesaler licence. Your application is currently incomplete and cannot be processed until the items described below have been filed. Also, your prior licence EW-2006-0062 has expired and you need to apply for an interim licence as described on page 2 of this letter to continue to operate in the wholesale market.

1. Please complete question 8 of the application, i.e. please describe the applicant's corporate organization and the applicant's relationship with its affiliates.
2. The financial information provided with your application is not sufficient for the Board to make a determination with regard to the applicant's financial position. Please provide financial statements for the applicant for the last two fiscal years. For details with respect to the financial statements submission requirements, please refer to question 9, Finance of the application.
3. Under question 10, Technical Resources, please briefly describe the technical qualifications of at least one person employed by the applicant or describe the services provided by ECNG Inc. with respect to wholesaling electricity.

The Board will resume processing your application once the above information has been filed.

Please file two paper copies of the additional material and an electronic version in Word and in searchable Adobe Acrobat (if available) with the Board Secretary. Electronic copies may be submitted on CD or by e-mail to boardsec@ontarioenergyboard.ca.

Section 57(e) of the Ontario Energy Board Act, 1998 provides that no person is permitted to purchase electricity or ancillary services in the IESO-administered markets without a licence. The licence EW-2006-0062 that you are currently renewing expired on May 23, 2011. Your application will be processed within 90 days from the date you application is deemed complete, i.e. when the Board receives all the items outlined in this letter. To bring you in compliance with licensing requirements to wholesale electricity stipulated in the OEB Act, the Board can issue an interim licence expeditiously. The interim licence will be valid until final determination of your licence application. Please send a letter requesting the issuance of an interim licence to the Board Secretary at boardsec@ontarioenergyboard.ca. In your letter please include a short paragraph explaining why you were operating without a licence, a request that the Board dispose of the proceeding without a hearing, pursuant to s.21 (4)(b) of the Ontario Energy Board Act, and provide some reasons as to why no person except for the applicant can be adversely affected in a material way by the outcome of a proceeding.
