**IN THE MATTER OF** section 92 of *Ontario Energy Board Act*;

**AND IN THE MATTER OF** an application by Ontario Power Generation Inc. for an order or orders of the Board granting Leave to construct transmission facilities in the Lower Mattagami region of Ontario.

### **PROCEDURAL ORDER NO. 1**

Ontario Power Generation Inc. (the "Applicant" or "OPG") has filed an application with the Ontario Energy Board, (the "Board") dated May 12, 2011 under section 92 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B for an order or orders of the Board granting leave to construct a new double circuit 230 kV transmission line, approximately 3 km in length, in the Lower Mattagami region of Ontario (the "Proposed Line").

The Board issued a Notice of Application and Hearing (the "Notice") on June 17, 2011. The Notice was published and served by the Applicant as directed by the Board. The Independent Electricity System Operator applied for and was granted intervenor status. An intervenor list is attached as Appendix "A" to this procedural order.

In the Notice, the Board indicated that it intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. The IESO did not express a preference with respect to whether the Board should deal with this matter by way of a written or oral hearing. The Board intends to proceed by way of written hearing.

However, the Board may include an oral component if in the Board's view it is warranted. This determination will be made at a later stage.

The Board considers it necessary to make provision for a number of procedural matters. Please be aware that further procedural orders may be issued from time to time.

#### **THE BOARD ORDERS THAT:**

1. Intervenor or Board staff who wish information and material from the Applicant that is in addition to the Applicant's pre-filed evidence and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the Applicant on or before **Friday August 26, 2011**. Where possible, the questions should specifically reference the pre-filed evidence.
2. The Applicant shall file with the Board complete responses to the interrogatories on or before **Friday September 9, 2011**.
3. The Applicant shall file any submission it wishes to, on or before **Friday September 16, 2011**.
4. Intervenor and Board Staff who wish to file submissions shall do so, with copies to the Applicant, on or before **Friday September 23, 2011**.
5. The Applicant shall file any reply submission it wishes to, on or before **Friday September 30, 2011**.

All filings to the Board must quote the file number, EB-2011-0056, be made through the Board's web portal at [www.errr.ontarioenergyboard.ca](http://www.errr.ontarioenergyboard.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca). If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD in searchable / unrestricted PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
