**IN THE MATTER OF** the *Ontario Energy Board Act,* 1998, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application under section 74 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B for a licence amendment by West Coast Huron Energy Inc. seeking an exemption from their time-of-use Pricing date for Regulated Price Plan Consumers.

#### PROCEDURAL ORDER NO. 1

West Coast Huron Energy Inc. ("West Coast Huron") filed an application dated June 16, 2011 with the Ontario Energy Board under section 74 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (Schedule B) for a licence amendment granting an extension in relation to the mandated date for the implementation of time-of-use ("TOU") pricing rates for certain Regulated Price Plan ("RPP") consumers. The Board assigned the application file number EB-2011-0241.

The Board issued a Notice of Application and Hearing on July 7, 2011. Board staff filed its submission on August 9, 2011. No other parties have intervened in the application.

The Notice of Application and Hearing required that if the applicant wished to respond to any submissions, to file a written response by August 16, 2011. On August 11, 2011, West Coast Huron filed a letter with the Board requesting additional time to file its reply submission. The applicant requested that it be given until August 23, 2011 to file its response.

The Board will grant the request.

Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.
