**Re: The Corporation of the City of Temiskaming Shores
Franchise Agreement and Certificate of Public Convenience and Necessity
Board File Numbers EB-2011-0263 and EB-2011-0264**

Union Gas Limited is in receipt of the Board Staff submission dated August 3, 2011 in the above proceedings. Board staff has requested that Union confirm that the existing Certificates of Public Convenience and Necessity cited in our application are to be cancelled in their entirety.

The existing Certificates are as follows:

F.B.C. 31 - the former Town of New Liskeard

In Union's application dated July 11, 2011, paragraph 8 should refer to F.B.C 31 as the Certificate related to the former Town of New Liskeard (not E.B.C. 31).

F.B.C. 31 is dated April 20, 1956 and was issued to the Northern Ontario Natural Gas Company Limited. It is related only to the supply of natural gas to the former Town of New Liskeard and the construction of related works.

In 1968, Northern Ontario Natural Gas, Twin City Gas and Lakeland Natural Gas merged into Northern and Central Gas Co. Ltd. which was purchased by Inter-City Gas Corp. The company changed its name to ICG Utilities (Ontario) Ltd. and then to Centra Gas Ontario Inc. Union Gas and Centra Gas amalgamated under the name of Union Gas Limited in 1998.

F.B.C. 27 and E.B.C. 9 - the former Town of Haileybury

F.B.C. 27 is dated April 20, 1956 and was issued to the Northern Ontario Natural Gas Company Limited. It is related only to the supply of natural gas to the former Town of Haileybury and the construction of related works.

E.B.C. 9 is dated January 23, 1962 and was issued to the Northern Ontario Natural Gas Company Limited. It is related only to the supply of natural gas to the former Township of Bucke and the construction of related works. In 1971, the former Township of Bucke and the former Town of Haileybury amalgamated.

E.B.C. 10 - the former Township of Dymond

E.B.C. 10 is dated August 7, 1962 and was issued to the Northern Ontario Natural Gas Company Limited. It is related only to the supply of natural gas to the former Township of Dymond and the construction of related works.

Union Gas hereby confirms its request for an Order pursuant to s.8 cancelling the 4 existing Certificates of Public Convenience and Necessity held by Union Gas Limited for the former municipalities within the City of Temiskaming Shores and replacing them with a single Certificate of Public Convenience and Necessity for those areas of the amalgamated Corporation of the City of Temiskaming Shores.
