NOTICE OF APPEAL

THE Grand Council Treaty #3 APPEALS to the Divisional Court from the final decision and order of the Ontario Energy Board dated July 25, 2011 made at Toronto.

THE APPELLANT ASKS that the order be set aside and that the matter be remitted to the Ontario Energy Board to be determined in accordance with these reasons and/or such directions as may be given by this court.

P.005/013

THE GROUNDS OF APPEAL are as follows:

- 1. The Ontario Energy Board erred in law by breaching the duty of procedural fairness owed to the Appellant by purporting to assess the adequacy of the consultation that had occurred when that issue had been excluded from the scope of the hearing by the procedural orders made by the Board;
- 2. The Ontario Energy Board erred in law by determining the adequacy of the Crown's duty to consult without providing the Grand Council Treaty #3 with the opportunity to make submissions regarding the adequacy of Crown consultation in regards to the Red Lake Project;
- 3. The Ontario Energy Board erred in law by holding that it did not have a duty to assess the adequacy of the consultation that had occurred in respect of other permits or authorizations associated with the Red Lake Project for the purpose of assessing whether or not adequate consultation had occurred in respect of the project as a whole;
- 4. The Ontario Energy Board erred in its interpretation of the law regarding the duty to consult such that it took an overly narrow view of the scope of impacts to be included in duty to consult and in particular excluded indirect and cumulative impacts from the duty to consult;
- 5. Such further and other grounds as counsel may advise and this Honourable Court deems just.

THE BASIS OF THE APPELLATE COURT'S JURISDICTION IS:

- 1. Section 33(1) of the *Ontario Energy Board Act*, which provides for an appeal to the Divisional Court from an order of the Board;
 - 2. The order appealed from is final;
 - 3. Leave to appeal is not required.

The appellant requests that this appeal be heard at Toronto.
