NOTICE OF APPLICATION AND PROCEDURAL ORDER FOR DISPOSITION OF DEFFERAL AND VARIANCE ACCOUNTS BY ENERSOURCE HYDRO MISSISSAUGA INC.

Enersource Hydro Mississauga Inc. ("Enersource") filed an application with the Ontario Energy Board (the "Board") on August 17, 2011 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B) (the "Act"), seeking an order or orders of the Board approving the disposition of amounts recorded in certain Group 1 deferral and variance accounts.

The application will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the Act. The employee does not intend to provide for an award of costs when deciding this application.

On July 31, 2009, the Board issued its Report of the Board on the Electricity Distributors' Deferral and Variance Account Review Initiative (the "EDDVAR Report") which sets out the policy framework for review and disposition of deferral and variance accounts for electricity distributors. In accordance with the Board's direction in the EDDVAR Report, and consistent with the Board's EB-2010-0078 Decision on Enersource's 2011 Incentive Rate Mechanism application, Enersource applied for approval to dispose of the balances as of December 31, 2010 of all Group 1 accounts and the related carrying charges up to October 31, 2011. Enersource proposes to dispose of these account balances by means of a rate rider over a four-year period commencing November 1, 2011. The Board has assigned the application File No. EB-2011-0266. The delegated authority's decision on this application may have an effect on all of Enersource's customers.

Delivery charges are one of four regular items on residential and general service customers' electric bills and vary depending on the amount of electricity consumed. If the application is fully approved, the monthly bill for a residential customer who consumes 800 kWh per month will decrease by about \$0.49. The monthly bill for a

general service customer consuming 2,000 kWh per month and having a monthly demand of less than 50 kW would decrease by about \$1.22. The proposed changes to the Delivery charge are separate from other potential changes to the electricity bills.

How to Participate

Any parties who wish information and material from the applicant that is in addition to the applicant's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before **September 16**, **2011**. Where possible, the questions should specifically reference the pre-filed evidence. The applicant shall file with the Board complete responses to the interrogatories and deliver them to any interested parties in the proceeding no later than **September 26**, **2011**.

Anyone who wishes to make a submission on the application must file that written submission with the Board and deliver it to the applicant by **October 11, 2011**. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by **October 21, 2011**. All written submissions sent to the Board will be placed on the public record. The written submissions will be available for viewing at the Board's offices and will be placed on the Board's website.

If the written submission is from a private citizen (i.e., not a lawyer representing a client, not a consultant representing a client or organization, not an individual in an organization that represents the interests of consumers or other groups, and not an individual from a regulated entity), before placing the written submission on the public record, the Board will remove any personal (i.e., not business) contact information from

the written submission (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.
