- 4. If Toronto Hydro-Electric System Limited is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
- 5. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
- To make a copy of the application and evidence, and any amendments thereto, available for public review at Toronto Hydro-Electric System Limited's office and on its website;
- 7. To make a copy of the Notice (in English and French) available for public review at Toronto Hydro-Electric System Limited's office and on its website; and,
