NOTICE OF APPLICATION

ENBRIDGE GAS DISTRIBUTION INC.

LEAVE TO CONSTRUCT TWENTY (20) KILOMETERS OF HIGH PRESSURE NATURAL GAS DISTRIBUTION PIPELINELINE AND RELATED FACILITIES FOR THE GEORGIAN BAY REINFORCEMENT PROJECT IN THE CITY OF BARRIE

Enbridge Gas Distribution Inc. ("EGD") has filed an application with the Ontario Energy Board, (the "Board") dated January 23, 2007, under section 90(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B for orders granting leave to construct approximately twenty kilometers of Nominal Pipe Size ("NPS") 12 extra high pressure ("XHP") main in the city of Barrie to meet the required load growth in the Georgian Bay area. The proposed facilities are located in the City of Barrie, Township of Springwater in the County of Simcoe.

The Board has assigned File No. EB-2007-0782 to this application.

The proposed NPS 12 XHP main will travel from the Barrie Gate Station, located on Anne Street in the City of Barrie, to the existing Enbridge NPS 8 XHP main at the intersection of Crossland Road and Flos Road in the Township of Springwater. The pipeline will leave the Barrie Gate Station and proceed northerly along Anne Street to Carson Road where it will proceed westerly to Wilson Drive. The pipeline will proceed along Wilson Drive northerly, crossing under the Canadian Pacific railway tracks, to Highway 26 where it will turn and proceed in a westerly direction to Vespra Valley Road whereupon it will turn and proceed northerly to Horseshoe Valley Road. The pipeline will proceed west along Horseshoe Valley Road to Crossland Road to the existing NPS 8 XHP gas main on the north side of Flos Road 4. The estimated costs of construction are \$12,436,426 and construction is scheduled to commence in May 2008 to be complete in October 2008.

A map showing the location of the proposed route is included as Appendix "A" in this Notice.

You may send the Board a letter of comment which will be provided to the Board members deciding the application, and will be part of the public record for the application. Your letter may include a request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the publication or service date of this notice. The Board accepts letters of comment by either post or e-mail at the address below.

2. Become an Observer

Observers do not actively participate in the proceeding but monitor the progress of the proceeding. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made in writing and be received by the Board no later than **10 days** from the publication or service date of this notice. If you become an observer, you need to contact the applicant and others in order to receive documents that they file in this proceeding and they may charge you for this. Most documents filed in this application will also be available on the Board's website. The Board accepts observer request letters by either post or e-mail at the addresses below; however, two paper copies are also required. You must also provide a copy of your letter to the applicant.

3. Become an Intervenor

You may request intervenor status if you wish to actively participate in the proceeding. Intervenors are eligible to receive evidence and other material submitted by participants in the hearing. Likewise, intervonors will be expected to send copies of any material they file to all parties to the hearing.

Your request must be made by letter of intervention and received no later than **10 days** from the publication or service date of this notice. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
