3. to immediately arrange for the Notice, headed with the Ontario Government logo and the words “Commission de l’énergie de l’Ontario”, to be published in one issue of the French-language local newspaper having the highest paid circulation, according to the best information available, in the Township of Coleman;
4. to file with the Board, affidavit evidence proving service and publication immediately upon completion, attaching as appendices the relevant Notice, application, and original post office registration receipts or courier receipts, but not the newspaper tear sheets;
5. to ensure that complete copies of the application are available for convenient public perusal at the addresses stated in the Notice; and
6. to immediately provide a copy of the application to any person upon request.
