This letter is in response to the Ontario Energy Board's ("OEB") Notice of Application and Hearing for an electricity distribution rate change by Toronto Hydro-Electric System Limited ("Toronto Hydro") for the years 2012 through 2014. The SSMWG is applying for intervenor status in this proceeding. The SSMWG intends to participate in the proceeding as is appropriate by any one or all of submitting interrogatories, filing evidence or submissions, undertaking cross-examination and/or filing argument.

Members of the SSMWG operate in the competitive unit sub-metering industry. Members offer unit sub-metering services ("SSM Services") to the developers and owners of multi-unit residential and commercial complexes. The SSM Services may include the installation of unit submetering equipment in individual suites, data collection and storage, invoicing and bill collections and customer care functions. Members of the SSMWG operate pursuant to the conditions of their OEB-issued licence and the Unit Sub-Metering Code.

Members of the SSMWG are interested in aspects of Toronto Hydro's Application that relate to suite metering and other related metering activities, including the application of the suite meter tariff ordered by the OEB in the EB-2010-0142

proceeding. If accepted, the SSMWG's intervention will focus on issues related to those activities.
