Re: OEB File No. EB-2011-0123
Guelph Hydro Electric Systems Inc. (Guelph Hydro)
2012 Electricity Distribution Rate Application

Please find enclosed Guelph Hydro's responses to most of the interrogatories from Intervenor in the above noted rate application. Of the 512 total interrogatories filed by Intervenor, Guelph Hydro is responding to 456 or 89% of the questions today.

- Due to the changes to Ontario Energy Board's filing requirements announced after Guelph Hydro filed its application and the recent release of updated models, Guelph Hydro has not completed all the interrogatories. A number of the interrogatories requested information that required the updated models to be completed prior to answering the questions.

The Board issued its decision and order in the combined proceeding on account 1562 deferred PILs (EB-2008-0381) on June 24, 2011. In this decision and order the Board stated that it expected distributors subject to section 93 of the *Electricity Act* to apply for final disposition of the balance in account 1562 in their next general rates application (either IRM or cost of service).

The Board Staff interrogatories requested Guelph hydro to file the evidence in the above matter. The evidence must be consistent with the level of detail found in the combined proceeding, including the findings in the Board's decision and the settled issues found in the settlement agreement.

Guelph Hydro estimated that an extended time is necessary to compile all the information and respond to the interrogatories related to account 1562 disposition at the requested level of detail.

Guelph Hydro expects to file the responses to the remaining interrogatories early the week of October 10.

The remaining interrogatories to be responded follows:


