## **BACKGROUND**

Haldimand County Hydro Inc. (“Haldimand County”) filed an application dated August 19, 2011 with the Ontario Energy for a licence amendment granting an extension in relation to the mandated date for the implementation of time-of-use (“TOU”) pricing rates for certain Regulated Price Plan consumers.

Haldimand County applied for an extension to its September 2011 TOU pricing date and requested a new date of January 31, 2012 for approximately 416 General Service <50kW and 40 Residential customers. Haldimand County stated the extension is necessary due to an issue with certain three phase meters for these customers that are delivering suspect interval data due to improper time-alignment of the consumption intervals.

The Board issued a Notice of Application and Hearing on September 2, 2011. Board staff filed interrogatories on the application on September 19, 2011. Haldimand County responded to these interrogatories on September 26, 2011.

This submission is being provided by Board staff following a review of the application and evidence filed in this proceeding.

## **STAFF SUBMISSION**

Having reviewed the application and evidence, Board staff supports Haldimand County’s request for an extension to its TOU pricing date.
