- The Vulnerable Energy Consumers Coalition (VECC) hereby expresses its intention to intervene and participate in the above-mentioned proceeding. VECC consists of the following organizations:
  - (a) The Federation of Metro Tenants Association (FTMA)
  - (b) The Ontario Coalition of Senior Citizens' Organizations (OCSCO)

2. The Federation of the Metro Tenants Association (the "FTMA") is a non-profit corporation composed of over ninety-two affiliated tenants associations, individual tenants, housing organizations, and members of non-profit housing co-oops. In addition to encouraging the organization of tenants and the promotion of decent and affordable housing, the Federation provides general information, advice, and assistance to tenants. 3. The Ontario Coalition of Senior Citizens' Organizations ("OCSCO") is a coalition of over 160 senior groups as well as individual members across Ontario. OCSCO represents the concerns of over 500,000 senior citizens through its group and individual members. OCSCO's mission is to improve the quality of life for Ontario's seniors. OCSCO's address is:

- 4. The coalition of the FMTA and OCSCO under the name VECC has the specific mandate of intervening in proceedings to advocate on behalf of the interests of Ontario's vulnerable consumers with respect to energy issues, primarily through intervention in regulatory proceedings at the Ontario Energy Board.
- 5. Although the organization is not itself a member of VECC, the Public Interest Advocacy Centre (PIAC) in Ottawa assists in the representation of

the interests of vulnerable consumers by ensuring the availability of competent representation and consultant support to the VECC participation.

- 8. VECC requests that a paper copy of the application and any additional supporting materials be forwarded to Dr. Higgin at the above address and that electronic copies be sent to both Mr. Buonaguro and Dr. Higgin at their respective e-mail addresses.
- VECC notes that EGD proposes to acquire RNG as part of its gas supply portfolio for customers who purchase their natural gas from the Company ("System Gas Customers"). EGD proposes that the costs of acquiring

RNG will constitute part of the Company's Purchased Gas Reference Price as determined through the Quarterly Rate Adjustment Mechanism ("QRAM"). The Board's disposition of this issue directly affects EGD system gas customers represented by VECC.

- VECC notes that it has previously been approved as an intervenor in numerous proceedings related to Enbridge Gas Distribution, including its last 4 IRM applications.
- 11. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable consumers of natural gas are fully represented in the determination of just and reasonable rates for gas commodity supply in 2012 and beyond.
- 12. VECC also notes that Union Gas Limited has filed a similar application. VECC is in the process of reviewing that application and respectfully requests that VECC be provided an opportunity to make submissions on the manner in which the EGD and Union applications are to be heard.
- 13. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
- 14. VECC's members do not have access to the direct funding required to retain appropriate legal and consulting support for its intervention in OEB proceedings. Accordingly VECC relies on PIAC to provide legal support

and retain qualified consultants on the basis that PIAC can recover the related fees and disbursements from the Board based on the Board's Practice Direction on Cost Awards at the prevailing Cost Award Tariff.
