INTERVENTION OF ENBRIDGE GAS DISTRIBUTION INC.


1. Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") hereby applies for Intervenor status in this proceeding pursuant to the above-captioned matters.
2. Enbridge is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting and storing natural gas within Ontario. The Company also undertakes Demand Side Management ("DSM") activities some of which are complimentary and/or similar to the DSM activities undertaken in the past and proposed by Union Gas Limited in its DSM Plan.
3. Enbridge has a direct interest in all matters of jurisdiction, substance, and procedure in the regulation of public utilities, and in any decision of the Ontario Energy Board ("Board"), which may create a precedent affecting the Company's own applications particularly in respect of its DSM activities.
4. Enbridge reserves the right to fully participate as an Intervenor in this proceeding and, should the Board decide to proceed by way of an oral proceeding, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.
