Please note that service by email is considered acceptable.

4. To make a copy of the application and evidence, and any amendments thereto, available for public review at EWT LP's office.
5. To inform the Board by way of letter directed to the Board Secretary that the notices have been posted on your website, immediately upon completion.
6. To inform the Board by way of letter directed to the Board Secretary that the notices have been served on all electricity transmitters licensed by the Board and on the electricity transmission licence applicants listed in paragraph 3 above, immediately upon completion.
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

All correspondence to the Board regarding this matter must quote file number EB-2011-0350 and must consist of one electronic copy e-mailed to BoardSec@ontarioenergyboard.ca and two hard copies filed with the Board Secretary.
