**Interrogatories to Blue Power Distributed Energy Corp**

Please see below for interrogatories from Bluewater Power Distribution Corporation (“Bluewater”) in regard to the above noted application.

1. Blue Power Distributed Energy Corp (“Blue Power”) states in its letter to the Board Secretary dated March 28, 2011 that “after careful consideration Blue Power agreed not to retail electricity to customers in Bluewater’s distribution area”. Please provide the following:
  - a. the communication wherein Blue Power communicated to Bluewater that it agreed not to retail electricity to customers in Bluewater’s territory;
  - b. confirmation as to whether Blue Power would be prepared to agree to a similar restriction with respect to the retailing of gas, or any other energy-related product, in Bluewater’s territory;
  - c. confirmation as to whether Blue Power would be prepared to accept, at a minimum, a restriction in its retail licence to retail electricity, gas or any energy-related product in Bluewater’s territory; and
  - d. because Bluewater’s territory is non-contiguous and proximate with Hydro One territory in Lambton County, confirmation as to whether Blue Power would be prepared to accept a restriction in its retail licence to retail electricity, gas or any energy-related product in Lambton County.
  
2. Blue Power Distributed Energy Corp was created in 2002 upon the completion of a NUANS name search that should have identified Bluewater Power Distribution Corporation as a conflicting name. Please provide the NUANS name search received at the time of filing for incorporation and any non-privileged communication from the lawyer or consultant who incorporated the company.

3. To date, has Blue Power undertaken any form of marketing of its services for electricity, gas or other energy related products in Lambton County?
4. Please provide copies of training materials wherein employees are instructed of their obligations under the Electricity Retailer Code of Conduct.
5. The logos of Blue Power and Bluewater share in common the two colours and the stylistic use of the letter “o” in the word “power”. Please provide, either or both:
  - a. presentations or proposals from a graphic designer or communication consultant wherein the logo was designed, including drafts of the logo, if applicable.
  - b. Any internal documentation discussing the development or approving of the logo design, including drafts of the logo, if applicable.
