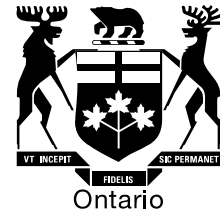

**IN THE MATTER OF** the *Ontario Energy Board Act*, 1998,  
S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Norfolk Power  
Distribution Inc. for an order approving just and reasonable  
rates and other charges for electricity distribution to be  
effective May 1, 2008.

### **PROCEDURAL ORDER No. 3**

Norfolk Power Distribution Inc. filed an application with the Ontario Energy Board, received on November 16, 2007 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Norfolk Power Distribution Inc. charges for electricity distribution, to be effective May 1, 2008. The Board has assigned the application file number EB-2007-0853. The Board issued a Notice of Application and Hearing dated December 5, 2007. The School Energy Coalition and the Vulnerable Energy Consumers' Coalition applied for and were granted intervenor status.

On January 7, 2008 the Board issued Procedural Order No. 1 wherein dates were established for certain events, including the issuing of Interrogatories and for Norfolk Power Distribution Inc. to respond to those Interrogatories. On January 29 Norfolk Power Distribution Inc. submitted a request to revise the date Interrogatory responses were due to February 15. The Board granted the request and issued Procedural Order No. 2 with revised dates for the proceeding.

Norfolk Power Distribution Inc. filed partial responses to interrogatories on February 15, filing the remaining responses on February 25. Due to this delay in filing the responses the Board has decided to make provision for the following procedural matters. This Procedural Order will supersede the dates in Procedural Order No. 2. Please be aware

that this procedural order may be amended, and further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. Intervenor or Board staff who wish to make a submission on the application must file that submission with the Board, and deliver it to the applicant and other intervenors by March 24, 2008.
2. If the applicant wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors by March 31, 2008.
3. All filings to the Board must quote file number EB-2007-0753, be made through the Board's web portal at [www.errr.oeb.gov.on.ca](http://www.errr.oeb.gov.on.ca), and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
4. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
