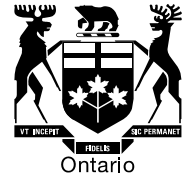

Your application and Notice are currently incomplete and cannot be processed until the following has been filed:

Application:

1. The contract number identified in the Notice to Proceed does not match the FIT Reference # in the application. Please clarify.
2. The applicant is Okikendawt Hydro L.P. As the applicant is a L.P., the application requires the general partner to sign the application on its behalf.

Notice of Proposal, Section 81:

1. To help the Board understand how all the parties are related in this Project, please provide an organizational chart (including applicant, affiliates and associated entities i.e. Hydromega Energy (Ont) Inc., general partner, Hydromega Services Inc., Dokis First Nation, etc.) as required per

Please also describe the applicant's corporate organization and the applicant's relationship with its affiliates and associated entities including a brief description of each entity's type of business.

2. 1.2.1 indicates that Hydromega Energy (Ont) Inc. has 75% participation and Dokis First Nation 25% participation.

As well, two individuals have a 50% participation in Hydromega Energy (Ont) Inc. Name the participant(s) of the remaining 50%.

1.3.1 states 80% participation by Hydromega Energy (Ont) Inc. with respect to four affiliates. Please name the participant(s) for the remaining balance for 1.3.1 as well as 1.3.4 and 1.5.2.

Please clarify what participation means (i.e. ownership and/or operation?).

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
