2. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Peterborough Distribution Incorporated's previous cost of service rate proceeding EB-2008-0241;

3. If Peterborough Distribution Incorporated is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
4. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
5. To make a copy of the application and evidence, and any amendments thereto, available for public review at Peterborough Distribution Incorporated's office and on its website;
6. To make a copy of the Notice available for public review at Peterborough Distribution Incorporated's office and on its website; and,
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
