Please note that invoices regarding publication are not to be sent to the Board.

2. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Middlesex Power Distribution Corporation - Main's previous cost of service rate proceeding RP-2005-0020/EB-2005-0351;
3. If Middlesex Power Distribution Corporation - Main is a Host Distributor, to

immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);

4. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
5. To make a copy of the application and evidence, and any amendments thereto, available for public review at Middlesex Power Distribution Corporation - Main's office and on its website;
6. To make a copy of the Notice available for public review at Middlesex Power Distribution Corporation - Main's office and on its website; and,
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
