2. To arrange immediately for the enclosed French version of the Notice headed with the Ontario Government logo and the words "Commission de l'énergie de l'Ontario", to be published in one issue of the French language newspaper having the highest circulation, according to the best information available, in Hydro One Remote Communities Inc.'s service area;

Please note that invoices regarding publication are not to be sent to the Board.

3. To arrange for the Cree, Ojibway and Oji-Cree versions of the Notice to be published in one issue of the Cree, Ojibway and Oji-Cree language newspaper having the highest circulation, according to the best information available, in or servicing Hydro One Remote Communities Inc.'s service areas;

Please note that invoices regarding publication are not to be sent to the Board.

4. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Hydro One Remote Communities Inc.'s previous cost of service rate proceeding EB-2008-0232;
5. If Hydro One Remote Communities Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
6. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
7. To make a copy of the application and evidence, and any amendments thereto, available for public review at Hydro One Remote Communities Inc.'s office and on its website;
8. To make a copy of the Notice available for public review at Hydro One Remote Communities Inc.'s office and on its website; and,
9. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
