PROCEDURAL ORDER NO.1

Enersource Hydro Mississauga Inc. ("Enersource") filed an application with the Ontario Energy Board (the "Board") on November 10, 2011 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Enersource charges for electricity distribution, to be effective May 1, 2012.

Enersource has requested that certain information provided in its Application be treated as confidential. Specifically, Enersource has requested that the evidence which supports the proposed 2012 Smart Meter Funding Adder, seen at Tab 4 and Attachment I of the Application, be treated as confidential pursuant to the Board's *Practice Direction on Confidential Filings* (the "Practice Direction").

The Practice Direction permits any party to a proceeding to object to the request for confidentiality by filing a written objection. This Procedural Order addresses the process for receiving such objections. Subsequent to any and all submissions received pursuant to this Procedural Order, the Board intends to make its findings with respect to Enersource's claim for confidentiality.

THE BOARD ORDERS THAT:

1. Board staff and intervenors may file with the Board and deliver to Enersource Hydro Mississauga Inc. and other parties any submissions with respect to the claim for confidentiality with respect to the evidence which supports the 2012 proposed Smart Meter Funding Adder submitted by Enersource Hydro Mississauga Inc. Such submissions shall be filed on or before **January 6, 2012**. Attached is appendix A, applicant and list of intervenors.
2. Enersource Hydro Mississauga Inc. may file a reply submission on or before **January 13, 2012** responding to any submissions filed by Board staff and intervenors with respect to Enersource Hydro Mississauga Inc.'s claim for confidentiality.

All filings to the Board must quote the file number, EB-2011-0100, be made through the Board's web portal at <https://www.errr.ontarioenergyboard.ca>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
