This letter is in response to your correspondence of March 10, 2008, which related to the two transmission licences issued by the Board on December 24, 2007 as part of the above noted combined proceeding. In your March 10, 2008 correspondence, you indicated that description of the applicable transmission systems in Schedule 1 of the transmission licences of Great Lakes Power Limited ("GLPL"), licence number ET-2002-0247, and Great Lakes Power Transmission Inc. ("GLPT") on behalf of Great Lakes Power Transmission LP ("GLPTLP"), licence number ET-2007-0649, is misstated.

In particular, you have indicated that the description of the applicable transmission systems contained in each Schedule 1 of the above noted licences should be:

- 318.25 circuit km of 230 kV line and associated equipment,
- 232.37 circuit km of 115 kV line and associated equipment, and
- 11 circuit km of 44 kV line and associated equipment which was deemed by the Board as serving a transmission function under Section 84 of the Act.

According to your correspondence of March 11, 2008, the intervenors in the above proceeding, namely the Vulnerable Energy Consumers Coalition, the Power Workers' Union, and the Independent Electricity System Operator, have no objection to the above noted correction being made to Schedule 1 of the transmission licences of GLPL (ET-2002-0247) and GLPT on behalf of GLPTLP (ET-2007-0649).

In accordance with Rule 43.02 of the Board's Rules of Practice and Procedure, the Board is correcting the description of the transmission systems in the above noted licences to properly reflect the transmission systems. Please find attached the corrected transmission licences for GLPL (ET-2002-0247) and GLPT on behalf of GLPTLP (ET-2007-0649).
