**Re: Westario Power Inc.
Application for Rates
Application Board File Number EB-2011-0205**

On December 14, 2011 the Board directed Westario Power Inc. ("WPI") to publish a Notice of Application (the "Notice") with respect to its 2012 3rd Generation IRM Rate Application within fourteen days. On January 16, 2012 WPI advised the Board that, due to an oversight, WPI failed to publish the Notice by the prescribed deadline and requested that a revised Notice be issued by the Board, which could be published on January 25, 2012.

Due to WPI's delay in publishing the originally issued Notice, the procedural steps set out in that Notice, including deadlines for filing interrogatories, responses, submissions and a reply submission need to be revised. Accordingly, the Board has determined to re-issue the Notice with revised filing dates which are extended by three weeks.

The Board directs the Applicant to publish the attached Notice by January 25, 2012 as follows:

1. To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one issue of the English language newspaper having the highest circulation, according to the best information available, in Westario Power Inc.'s service area;

Please note that invoices regarding publication are not to be sent to the Board.

2. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Westario Power Inc.'s previous cost of service rate proceeding EB-2008-0250;
3. If Westario Power Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
4. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter;
5. To make a copy of the application and evidence, and any amendments thereto, available for public review at Westario Power Inc.'s office and on its website;
6. To make a copy of the Notice available for public review at Westario Power Inc.'s office and on its website; and,
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
