REQUEST FOR REASONS

THE AFFECTED PERSON/CONSUMER, R. J. POTOMSKI,REQUESTS, pursuant to Section 17(1) of the Statutory Powers Procedure Act, R.S.O. 1990, c. S.22, the Ontario Energy Board give reasons for its decisions, dated January 24, 2012 and January 19, 2012, that include but not limited to the following:

- Not to accept the Notice of Appeal of R.J. Potomski (RJP), dated December 27, 2011 as a Notice of Appeal made pursuant to Section 7 of the Ontario Energy Board Act, 1998, S.O. 1998, c. 15, Schedule B;
- Not to accept RJP's right to appeal a decision of an employee of the OEB as a person who made submissions within OEB file # EB-2011-0291;
- To consider the Notice of Appeal and Supplementary Notice of Appeal to be a request for review.
- 4. To accept that Enwin Utilities Ltd. in a letter dated January 5, 2012 could question the statutory right of R.J. Potomski to appeal a decision of an employee of the OEB pursuant section 7 of the Ontario Energy Board Act.
- 5. To require R.J. Potomski to obtain leave to appeal by having him make submissions that are not unlike that which is required in the court system when leave to appeal is required.
- 6. Not to require Enwin Utilities to submit facts and law supporting its position stated in the letter dated January 5, 2012, prior to accepting the letter and directing R.J. Potomski to address Enwin's concerns.
