We are prepared to accept the record as it stands. Although we would be happy to respond to any concerns that the Applicant might raise, we do not believe that any unfairness arises from our late intervention.

The nature of our group is to educate and advocate for justice and truth in nature and communities beset by industrial wind turbines and attendant substations and transmission lines. We additionally work closely with the over 400 European groups (over 600 groups between the two organizations), as that history with IWTs predates ours, and we share a common understanding and expertise in working with experts world wide. This expertise and knowledge of the problems with industrial wind worldwide can and does work to impact other less mature experiences and policies.

Because of our group's interests and history, we have a concern about the proposed development described in the above noted application.

We have communicated with MCSEA and identified a commonality of interests. To the extent possible, we will coordinate our intervention with that of MCSEA and other parties of similar interest.

We are not seeking eligibility for costs. To the extent possible, we intend to work with MCSEA's consultant, Mr. Adams.
