**Re Milton Hydro Distribution Inc., Distribution Licence ED-2003-0014  
Application to Amend Licenced Service Area**

Milton Hydro Distribution Inc. ("Milton Hydro") is making a Service Area Amendment Application ("SAA Application") to the Ontario Energy Board ("OEB") to expand its licensed distribution service territory to include one residential property located at 6719 McNiven Road, currently located in the licensed distribution service territory of Burlington Hydro Inc. ("BHI"), for the purpose of servicing this property. Both BHI and the residential customer requested Milton Hydro to install a residential secondary service to a new home being constructed on the property.

Milton Hydro installed a 400A 120/240V service to the property and connected the customer in November 2011. This SAA Application will eliminate the need to establish a new Long Term Load Transfer customer with BHI.

Milton Hydro's SAA Application is set out in the order of the OEB's Filing Requirements for Service Area Amendment Applications, EB-2006-0327 issued March 12, 2007 and includes the letter of consent from BHI and the Offer to Connect accepted by the residential customer.

This SAA Application is uncontested and as such Milton Hydro respectfully requests that the OEB proceed with this application in an expeditious manner without a hearing, pursuant to subsection 21(4) of the *Ontario Energy Board Act, 1998*.

## APPLICATION FOR APPROVAL OF A SERVICE AREA AMENDMENT

### 7.0 Introduction

*This application for a Service Area Amendment is structured to follow the minimum filing requirements for Service Area Amendment Applications as specified by the Ontario Energy Board. The filing requirements and responses are set out below.*

### 7.1 Basic Facts

Milton Hydro Distribution Inc. ("Milton Hydro") was been requested to provide a new service to a Burlington Hydro Inc. ("BHI") customer located at 6719 McNiven Road, Burlington, Ontario. BHI does not have legal access to provide the electricity service to this property. BHI has also provided correspondence stating that BHI has no objection to and consents to Milton Hydro accepting 6719 McNiven Road as a Milton Hydro customer. As such, Milton Hydro is submitting this Service Area Amendment Application ("SAA Application") to have its Distribution Licence ED-2003-0014 amended to include the property known as 6719 McNiven Road.

Milton Hydro's SAA Application is set out in the order of the Ontario Energy Board ("OEB") Filing Requirements for Service Area Amendment Applications, EB-2006-0327 issued March 12, 2007.

This SAA Application should occur as the customer has constructed a new home and the only available supply of electricity comes from Milton Hydro's distribution system. The customer was connected by Milton Hydro in November 2011. The approval of this SAA Application eliminates the establishment of a new Long Term Load Transfer ("LTTL") customer. Furthermore, BHI consents to the SAA Application.

The physical connection is a 400 Amp 120/240 Volt service to a single residential customer who has constructed a new home.

Milton Hydro owns and operates a 13.8 kV overhead distribution system along Derry Road contiguous to 6719 McNiven Road which has frontage on both McNiven Road and Derry Road. The service to this customer is fed from Milton Hydro's overhead distribution system.

Milton Hydro does not have any other plans for expansion in this area.

## 7.2 EFFICIENT RATIONALIZATION OF THE DISTRIBUTION SYSTEM

*The proposed SAA will be evaluated in terms of rational and efficient service area realignment. This evaluation will be undertaken from the perspective of economic (cost) efficiency as well as engineering (technical) efficiency.*

BHI does not have a distribution system available to service the customer nor does BHI have legal access to property in order to construct a feeder to the property without building within Milton Hydro's service area. Milton Hydro has a 13.8 kV overhead distribution system contiguous to the customer's property and therefore there is no additional cost to Milton Hydro to service this customer.

The connection of this customer will not impact system reliability for the area.

## 7.2.1 ECONOMIC AND ENGINEERING EFFICIENCY

The point of delivery is from Milton Hydro's 13.8 kV overhead line on Derry Road which runs in front of the customers property to an overhead customer owned pole. The customer installed the underground service from the pole to the house.

*Proximity of the proposed connection to an existing, well-developed electricity distribution system.*

Milton Hydro provided a new 400A 120/240V residential service to 6719 McNiven Road from its 13.8 kV overhead line on Derry Road to the customer owned pole.

Milton Hydro provided the basic overhead connection to the customer owned pole and the customer paid the balance of the cost to connect.

**7.2.1 (d)**

The estimated cost for connection assets was \$7,520.00; final costs have not been billed yet.

There are no stranded assets.

The infrastructure is a new 400A 120/240V residential service to 6719 McNiven Road and is not intended for cost-efficient improvements and upgrades.

## 7.3 IMPACTS ARISING FROM THE PROPOSED AMENDMENT

### Description of Impacts

#### 7.3.1

This SAA Application impacts one new residential customer who is also the landowner of 6719 McNiven Road, Burlington, Ontario.

Milton Hydro's distribution rates for the average Residential customer using 800 kWhs per month are \$0.39 per month higher than BHI. This Residential customer is a new customer in a newly constructed home and had requested and accepted Milton Hydro's Offer to Connect.

There will be no impact on service quality or reliability.

Milton Hydro will not incur any additional costs to service this customer.

There are no impacts with the proposed SAA

Milton Hydro will add one new customer which eliminates the need for a new Long Term Load Transfer ("LTLT") customer with BHI.

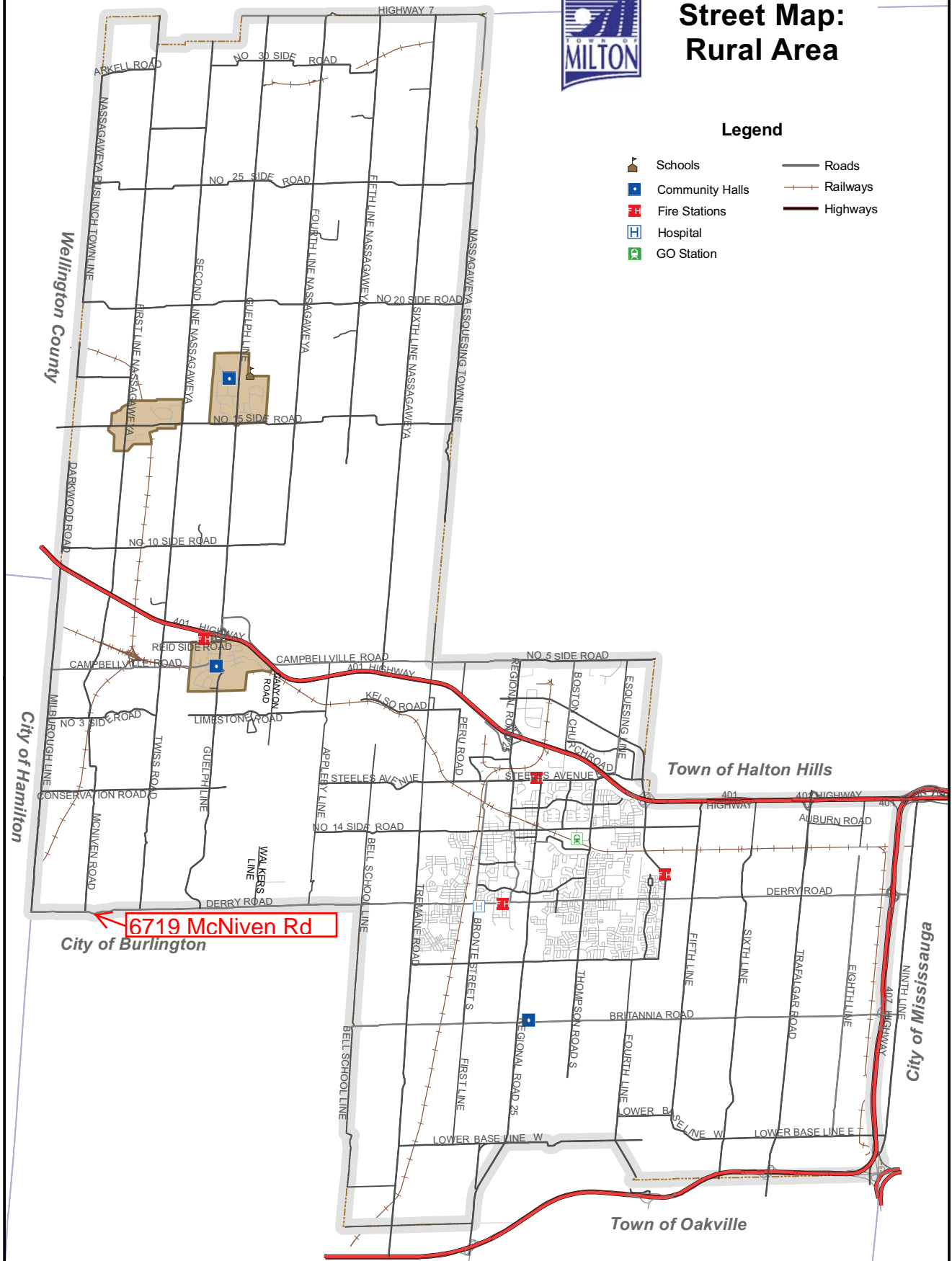




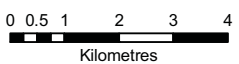
# Street Map: Rural Area

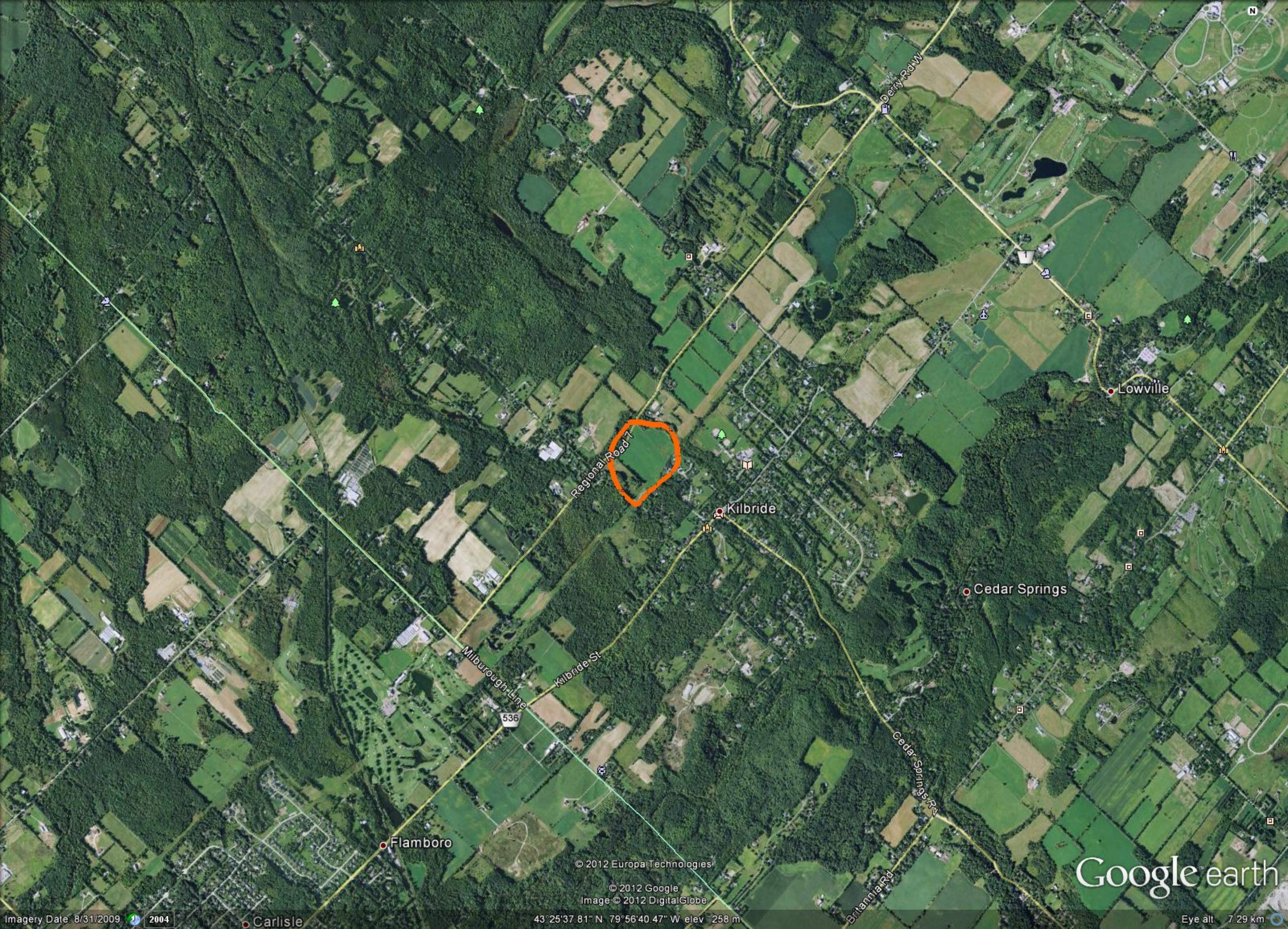
