We are counsel to McLean's Mountain Wind Limited Partnership ("McLean's") in this matter.

Exhibit E, Tab 1, Schedule 5 of the pre-filed evidence ("Design Specifications And Operational Data: Overhead Line Design Drawings And Stringing Charts") was initially filed in confidence. McLean's placed it on the public record in this proceeding on February 17, 2012 and provided copies to the intervenors by courier last week as part of its delivery of paper and electronic copies of the non-confidential pre-filed evidence in response to Mr. Beaudry's recent request in that regard.
