

**LICENCE TO DRILL WELLS WITHIN THE SARNIA AIRPORT POOL, IN THE
CITY OF SARNIA, COUNTY OF LAMBTON**

Market Hub Partners Management Inc. and AltaGas Ltd., on behalf of Sarnia Airport Storage Pool Limited Partnership (the "Applicants") have filed applications with the Ontario Energy Board, (the "Board") dated December 31, 2007, under sections 36.1(1), 38(1), 40(1) and 90(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B that would, if granted, allow the Applicants to develop Sarnia Airport Gas Storage Pool in the geographic area of the City of Sarnia, County of Lambton, Ontario ("Sarnia Airport Pool Project").

The Applicant has applied to the Board for the following:

- An Order designating the area containing a gas reservoir known as the Sarnia Airport Pool located in Lots 10 and 11, Concession Gore; Lots 10, 11 and 12, Concession 8; Lots 29, 30, 31, 32, 33 and 34 Front Concession; Lots 1, 2, 3, 4 and 5, North Division, Registered Plan 7; and Lots 1, 2, 3 and 4, South Division, Registered Plan 7; and public road allowance of Michigan Line, in the City of Sarnia in the County of Lambton, as a storage area pursuant to section 36.1(1) of the Act;
- Authority to inject gas into, store gas in, and remove gas from the Sarnia Airport Gas Storage Pool, pursuant to subsection 38(1) of the Act;
- A favourable report of the Board under subsection 40(1) of the Act, to the Minister of Natural Resources to whom MHP Canada has applied for a licence to drill three (3) injection/withdrawal wells and re-enter and complete one (1) existing well within the proposed Sarnia Airport Gas Storage Pool;
- Leave to construct about 16 kilometres of transmission and about 2 kilometres of gathering pipelines within the proposed Sarnia Airport Gas Storage Pool, pursuant to subsection 90(1) of the Act.

The Applicants have applied for an order of the Board for leave to construct approximately 2 kilometres of 12 inch Nominal Size Pipe ("NPS") gathering pipeline connecting the wells to the transmission pipeline system. The proposed storage gathering pipeline will be located entirely within the proposed Sarnia Airport Storage Pool in Lot 2 S.D., Registered Plan 7 and Lots 1 and 2, N.D., Registered Plan 7, City of Sarnia (formerly Township of Sarnia). The Applicants have also applied for an order of the Board for leave to construct approximately 16 kilometres of NPS 12 transmission pipeline connecting the storage gathering system to the interconnection to the Ontario pipeline network through the Union Gas Limited ("Union") system. The proposed transmission pipeline will be located within easement within Lot 10, Concession Gore, City of Sarnia, County of Lambton with the remainder being located within road allowance from Lot 2, N.D., Registered Plan 7, City of Sarnia to the connection to the Union system in Lot 1, Concession 1, Township of St. Clair. The proposed transmission line would commence at the proposed commingling point in Lots 1 and 2, N.D., City of Sarnia run east within road allowance until entering easement at Lot 10, Concession Gore, City of Sarnia, and then re-enter road allowance on Michigan Line west of Telfer Road. The proposed transmission line will then continue east within the Michigan Road

allowance to Waterworks Road then would run south within the road allowance of Waterworks Road to Churchill Line and run east to Churchill Line to Mandaumin Road to the interconnection with Union system in Lot 1, Concession 1, Township of St. Clair (formerly Township of Moore).

By a letter, dated January 25, 2008, the Ministry of Natural Resources, Petroleum Resources Centre, has referred to the Board, pursuant to section 40 of the Act an application by Market Hub Partners Canada L.P. for licences to re-enter and complete 1 existing well and to drill 3 injection/withdrawal wells in the proposed Sarnia Airport Gas Storage Pool, as follows:

- Bluewater True, Sarnia 2-11-VIII
- Airport No. 1 (Horizontal 1). Sarnia 8-32-FLH
- Airport No. 3 (Horizontal 1). Sarnia 2-11-VIII
- Airport No. 4 (Horizontal 1). Sarnia 2-11-VIII

The Applicant has proposed to develop about 5.26 Bcf of natural gas working storage space in the proposed Sarnia Airport Gas Storage Pool with the planned in-service date of April 2009.

The Board has assigned File No. EB-2008-0002 to this Application.

A map showing the location of the proposed wells and pipelines is included as appendix "A" in this Notice.

Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. 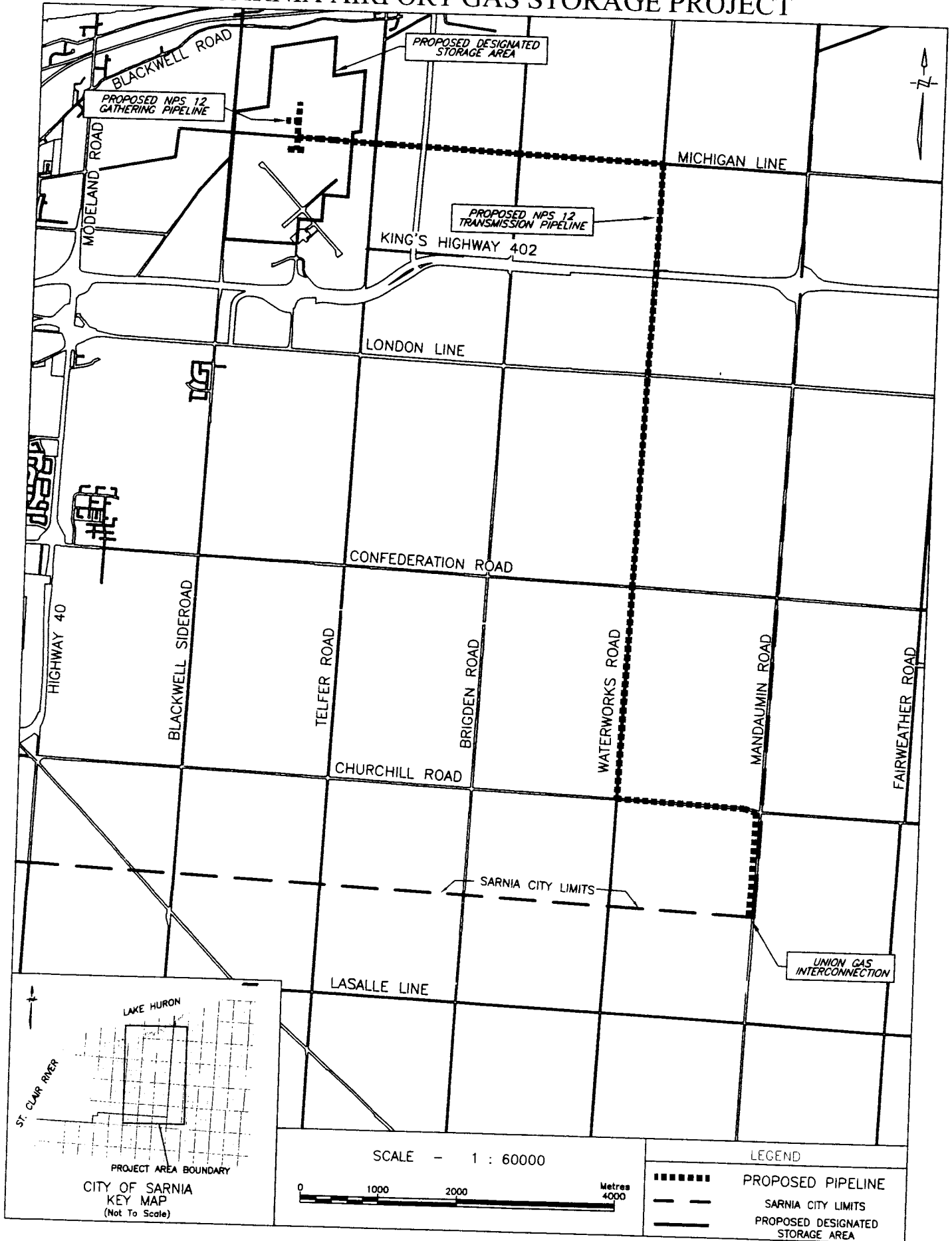
Map showing the location of the proposed pipelines and wells

AND IN THE MATTER OF an Application by Market Hub Partners Management Inc. and AltaGas Ltd., on behalf of Sarnia Airport Storage Pool Limited Partnership, for an Order granting leave to construct natural gas pipelines in the City of Sarnia, in the County of Lambton, and in the County of Lambton.

Sarnia Airport Storage Pool Project

1. Market Hub Partners Management Inc. and AltaGas Ltd., on behalf of Sarnia Airport Storage Pool Limited Partnership, a limited partnership that is being formed under the laws of Ontario (hereinafter referred to as the "Applicant") by respective subsidiaries of Market Hub Partners Management Inc. and AltaGas Ltd., seeks to designate and develop a natural gas reservoir as a natural gas storage pool for service commencing in 2009 in order to meet market demand for underground natural gas storage.
2. The Applicant hereby applies to the Ontario Energy Board (hereinafter referred to as the "Board") pursuant to section 36.1(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B (hereinafter referred to as the "Act"), for an Order designating the area containing a gas reservoir known as the Sarnia Airport Pool located in Lots 10 and 11,

Concession Gore; Lots 10, 11 and 12, Concession 8; Lots 29, 30, 31, 32, 33, and 34, Front Concession; Lots 1, 2, 3, 4 and 5, North Division, Registered Plan 7; and Lots 1, 2, 3 and 4, South Division, Registered Plan 7; and public road allowance of Michigan Line, in the City of Sarnia, in the County of Lambton, as a gas storage area (hereinafter referred to as the "Sarnia Airport Pool").


3. The Applicant further applies to the Board pursuant to section 38(1) of the Act for authority to inject gas into, store gas in and remove gas from the Sarnia Airport Pool, and enter into and upon the lands in the area for such purposes.
4. Pursuant to section 40(1) of the Act, the Applicant seeks a favourable report from the Board to the Ministry of Natural Resources to whom application has been made for a license to drill three (3) injection/withdrawal wells and re-enter and complete one (1) existing well within the proposed designated storage area (hereinafter referred to as the "DSA") of the Sarnia Airport Pool.
5. The Applicant further applies to the Board pursuant to section 90(1) of the Act for an Order or Orders granting leave to construct approximately two (2) kilometres of NPS 12 storage gathering pipeline in the proposed DSA of the Sarnia Airport Pool (hereinafter referred to as the "storage gathering pipeline") and approximately sixteen (16) kilometres of NPS 12 transmission pipeline (hereinafter referred to as the "transmission pipeline") to connect the storage gathering pipeline to the Ontario natural gas pipeline network through an interconnection with the Union Gas Limited system.
6. The Applicant requests such further or other related relief as the Applicant may request or as the Board may deem appropriate pursuant to the Act.
7. Attached hereto as Schedule A, is a description of the lands within the Sarnia Airport Pool for which designation is sought.
8. Attached hereto as Schedule B, is general location mapping for the Sarnia Airport Pool. Schedule B-1 is a map showing the general location of the proposed Sarnia Airport Pool DSA, the proposed storage gathering pipeline, and the proposed transmission pipeline. Schedule B-2 is a map showing the location of the pipelines and well locations within the proposed Sarnia Airport Pool DSA in more detail.
9. Attached hereto as Schedule C, is a list of the parties who are affected by the Application for designation and development of the Sarnia Airport Pool, including the owners of property within the proposed Sarnia Airport Pool DSA, owners of property adjacent to the proposed Sarnia Airport Pool DSA, owners of property through which easements are required for the proposed transmission pipeline, and owners of property adjacent to the proposed transmission pipeline.
10. In order to meet an in-service date as early as April 2009 for the Sarnia Airport Pool, the Applicant anticipates that commitments for project materials will commence as early as

March 2008 and will escalate throughout the remainder of that year. The Applicant respectfully requests, therefore the Board's timely approval of this Application not later than June 30, 2008.



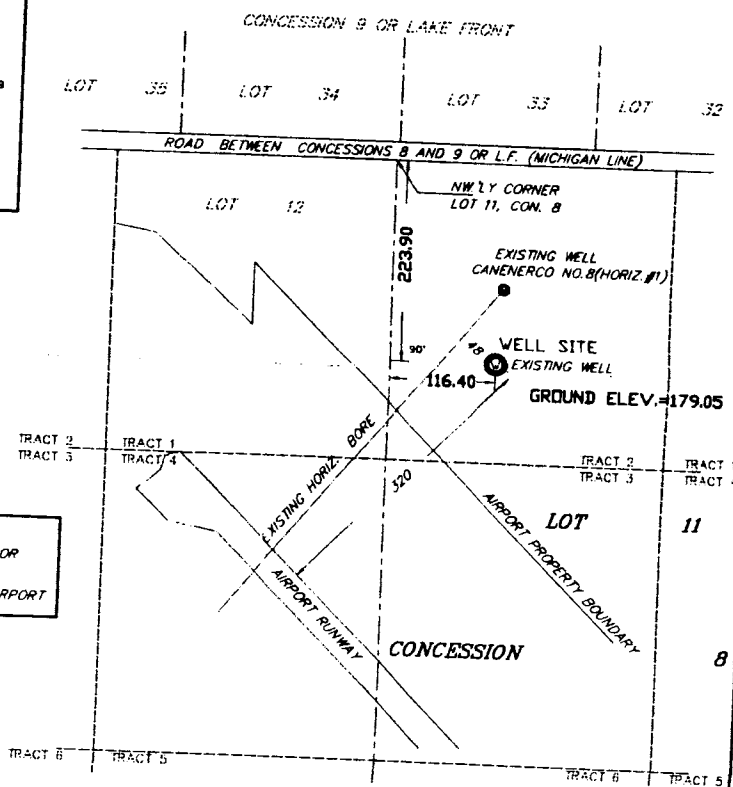


**PLAN OF EXISTING WELL

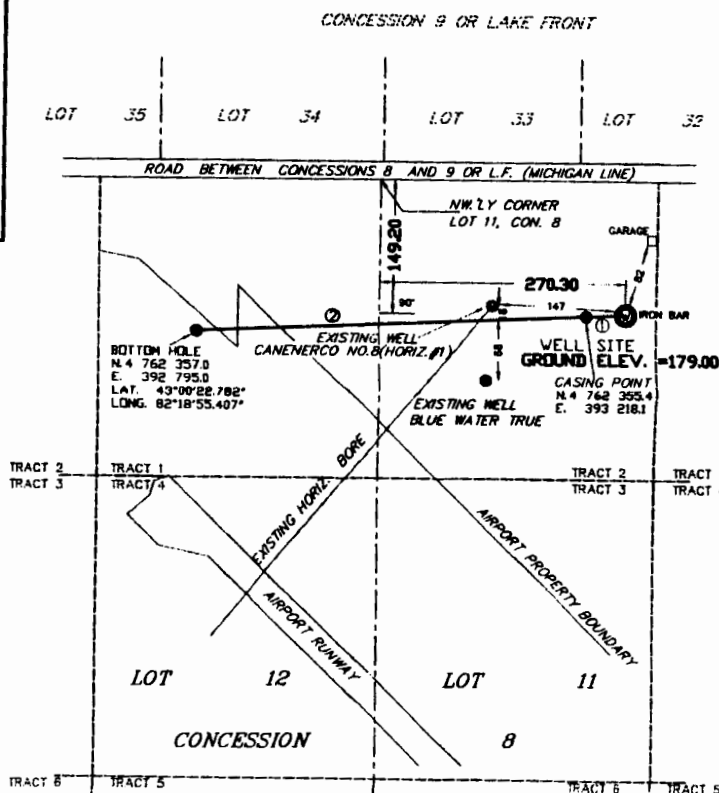

(on behalf of Sarnia Airport Storage Pool Limited Partnership (the "Applicants") have filed applications with the Ontario Energy Board (the "Board") dated December 31, 2007, under sections 30(1), 38(1), 40(1) and 90(1) of the Ontario Energy Board Act, 1996, S.O. 1996, c.15, Schedule B that would, if granted, allow the Applicants to develop Sarnia Airport Gas Storage Pool in the geographic area of the City of Sarnia, County of Lambton, Ontario ("Sarnia Airport Pool Project").

The Applicant has applied to the Board for the following:

- An Order designating the area containing a gas reservoir known as the Sarnia Airport Pool located in Lots 10 and 11, Concession Gore, Lots 10, 11 and 12, Concession B, Lot 20, 30, 31, 32, 33 and 34, Front Concession, Lots 1, 2, 3, 4 and 5, North Division, Registered Plan 7, and Lots 1, 2, 3 and 4, South Division, Registered Plan 7, and public road allowance of Michigan Line, in the City of Sarnia in the County of Lambton, as a storage area pursuant to section 38(1) of the Act;
- Authority to inject gas into, store gas in, and remove gas from the Sarnia Airport Gas Storage Pool, pursuant to subsection 38(1) of the Act;
- A favourable report of the Board under subsection 40(1) of the Act, to the Minister of Natural Resources to whom MHR Canada has applied for a licence to drill three (3) injection/withdrawal wells and re-enter and complete one (1) existing well within the proposed Sarnia Airport Gas Storage Pool;
- Leave to construct about 16 kilometres of transmission and about 2 kilometres of gathering pipelines within the proposed Sarnia Airport Gas Storage Pool, pursuant to subsection 90(1) of the Act.

The Applicants have applied for an order of the Board for leave to construct approximately 2 kilometres of 12-inch Nominal Size Pipe (NPS) gathering pipelines connecting the wells to the transmission pipeline system. The proposed storage gathering pipeline will be located entirely within the proposed Sarnia Airport Storage Pool in Lot 2 S.D., Registered Plan 7, and Lots 1 and 2, N.D., Registered Plan 7, City of Sarnia (formerly Township of Sarnia). The Applicants have also applied for an order of the Board for leave to construct approximately 16 kilometres of NPS 12 transmission pipeline connecting the storage gathering system to the interconnection to the Ontario pipeline network through the Union Gas Limited ("Union") system. The proposed transmission pipeline will be located within easement within Lot 10, Concession Gore, City of Sarnia, County of Lambton with the remainder being located within road allowance on Michigan Line west of Taylor Road. The proposed transmission line will then continue east within the Michigan Road allowance to Waterworks Road then would run south within the road allowance of Waterworks Road to Church Line and run east to Church Line to Mandam Road, the interconnection with Union system in Lot 1, Concession 1, Township of St. Clair. The proposed transmission line would commence at the proposed connecting point in Lots 1 and 2, N.D., City of Sarnia run east within road allowance until entering easement at Lot 10, Concession Gore, City of Sarnia, and then re-enter road allowance on Michigan Line west of Taylor Road. The proposed transmission line will then continue east within the Michigan Road allowance to Waterworks Road then would run south within the road allowance of Waterworks Road to Church Line and run east to Church Line to Mandam Road, the interconnection with Union system in Lot 1, Concession 1, Township of St. Clair (formerly Township of Moore).

By a letter, dated January 25, 2008, the Minister of Natural Resources, Petroleum Resources Centre, has referred to the Board, pursuant to section 40 of the Act an application by Market Hub Partners Canada L.P. for licences to re-enter and complete 1 existing well and to drill 3 injection/withdrawal wells in the proposed Sarnia Airport Gas Storage Pool as follows:

- Bluewater True, Sarnia 2-11-VIII
- Airport No. 1 (Horizontal) 1, Sarnia R-32-F.H
- Airport No. 3 (Horizontal) 1, Sarnia 2-11-VIII
- Airport No. 4 (Horizontal) 1, Sarnia 2-11-VIII

The Applicant has proposed to develop about 5.26 Bcf of natural gas working storage space in the proposed Sarnia Airport Gas Storage Pool with the planned in-service date of April 2009. The Board has assigned File No. EB-2008-0002 to this Application. A map showing the location of the proposed wells and pipelines is included herein.

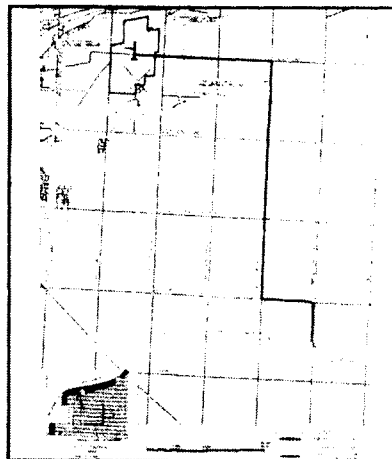
