IN THE MATTER OF the *Ontario Energy Board Act* 1998, S.O.1998, c.15, (Schedule B);

AND IN THE MATTER OF an Application by Union Gas Limited for an Order pursuant to Section 90 of the *Ontario Energy Board Act, 1998,* granting leave to construct a natural gas pipeline and related facilities in the Town of Halton Hills and the Town of Milton.

PROCEDURAL ORDER NO. 1

Union Gas Limited (the "Applicant") has filed an application with the Ontario Energy Board; (the "Board") dated January 25, 2008 under section 90 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B. The Applicant has applied for an order of the Board for leave to construct approximately 4.5 kilometres of 20 inch diameter natural gas pipeline in the Town of Halton Hills and the Town of Milton. The purpose of the pipeline is to supply natural gas to Halton Hills Generating Station currently being constructed by TransCanada Energy Ltd. near the southwest corner of Steeles Avenue and 6th Line in the Town of Halton Hills.

The Board has assigned File No. EB-2008-0024 to this application.

The Board issued a Notice of Application and Hearing on February 12, 2008. The Notice of Application and Hearing was published and served by the Applicant as directed by the Board. An intervenor list is attached as Appendix "A" to this Procedural Order.

The Board has decided to proceed with this case by way of a written hearing. However, the Board may hold an oral hearing for any component of the application should the Board find it necessary. The Board considers it necessary to make provision for a number of procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

- 1. Intervenors and Board staff who wish information from the Applicant that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the Applicant and the other Intervenors on or before **Monday**, **April 7**, **2008**.
- 2. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors on or before **Thursday**, **April 17**, **2008**.
- 3. Intervenors and Board staff who wish to make a submission on the application must file that submission with the Board, and deliver it to the Applicant and other intervenors on or before **Monday, April 28, 2008.**
- 4. If the Applicant wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors on or before **Thursday**, **May 8**, **2008**.
- 5. All filings to the Board must quote file number EB-2008-0024. If you already have a user ID, please submit your responses through the Board's web portal at www.errr.oeb.gov.on.ca. Additionally, two paper copies are required. If you do not have a user ID, please visit the Board's website under e-Filing and fill out a user ID password request. For instructions on how to submit and naming conventions please refer to the RESS Document Guidelines found at www.oeb.gov.on.ca, e-Filing Services. The Board also accepts responses by email, at the address shown in Appendix "A", and again, two additional paper copies are required. Those who do not have internet access are required to submit their intervention request on a CD or diskette in PDF format, along with two paper copies.
