### NOTICE OF APPLICATION

# ENBRIDGE GAS DISTRIBUTION INC. LEAVE TO CONSTRUCT NATURAL GAS PIPELINE ANGUS SYSTEM REINFORCEMENT

Enbridge Gas Distribution Inc. ("Enbridge") has filed an application with the Ontario Energy Board on February 16, 2012 under section 90 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, Schedule B for an order granting leave to construct approximately 10.1 kilometres of 152 millimeter diameter (Nominal Pipe Size 6 inch) Extra High Pressure ("XHP") steel pipeline (the "pipeline") to reinforce the existing natural gas delivery system in the Angus Ontario area. The Board has assigned the application file number EB-2012-0013.

The proposed pipeline route begins at Enbridge's Thornton Gate Station located at 4118 Innisfil Beach Road in the Town of Innisfil and proceeds west along the south side of the road allowance of Innisfil Beach Road for approximately 650 metres to Barrie Street. The pipeline then crosses Barrie Street at the Innisfil Beach Road intersection and continues southwest along the Trans Canada Trail for 530 m to County Road 21. The pipeline then follows County Road 21 westwards for 8.9 kilometres to terminate east of the intersection of Murphy Road (also called County Road 21) and Denney Drive in Baxter.

In addition to the proposed pipeline, a 7.7 km section of existing NPS 6 XHP steel pipeline is intended to be pressure elevated and a new pressure regulating station will be constructed south of the Village of Angus on County Road 10.

A map showing the location of the proposed route is attached as Appendix "A" to this Notice.

The pipeline is to be located mostly within the municipal road allowance. Construction of the pipeline is planned to start in July 2012. The proposed in-service timing for the pipeline is December 2012.

### Comment

If you wish to give your opinion on the proceeding to the Board members hearing the application, you are invited to send a written letter of comment to the Board no later than **30 days** after the publication or service date of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the Hearing Panel. All letters of comment will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letter of comment on the public record, the Board will remove any personal (i.e., not business) contact information from the letter of comment (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter of comment will become part of the public record. Please address your letter of comment to the Board Secretary at the address below, and reference file number **EB-2012-0013** at the top of your letter.

## Observe

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or service date of this notice.
